

Dear Defenders of Life,

There are many ways you can support the pro-life cause - by prayer, by peaceful witnessing at abortion mills, by writing letters to the editors, by political action and by financial support. As Chair of the Long Island Coalition for Life, I am asking for your financial support at this time.

The LICL is a completely voluntary organization. Its Board of Directors and committee members receive no financial compensation. All of your contributions go directly for pro-life work.

Education is the first and foremost purpose of the LICL. We have provided pro-life speakers at Long Island high schools and colleges. We have pro-life displays at street fairs. We have a presence at abortion mills where we distribute business-size cards in English and Spanish that provide crisis pregnancy help phone numbers and websites. Our biggest expense is the publication of *Life News*, an essential educational tool.

Our Educational Trust promoted a pre-screening of the movie about America's most notorious abortionist entitled "**Gosnell: America's Biggest Serial Killer.**" Our efforts filled the seats of the United Artist Regal Cinema in Farmingdale. Additionally, this coming Spring, The Trust will once again sponsor a pro-life Oratory Contest for high school students. The Trust now has business cards for the newly created website, [www.ProlifeED.com](http://www.ProlifeED.com). This past summer, the Trust sponsored radio ads on WBLI. The mobile truck billboard campaign will continue through the end of the year with the message "Peace Begins in the Womb."

The LICL has also sponsored lobby-bus trips to Albany to stop anti-life legislation; such as, abortion expansion and assisted suicide bills. These bills are still pending in our State legislature, just hanging like the "sword of Damocles" over the preborn, the disabled, and the elderly.

The historian, Hannah Arendt, once described Nazism as "the banality of evil." By this, she meant that evil had been normalized in Nazi Germany. And of course, in our own country the evil of slavery had once been normalized. In the United States today, we average over 3,000 abortions a day, more than 60 million since the Supreme Court legalized abortion through all nine-months of pregnancy with its *Roe v. Wade & Doe v. Bolton* decisions in January 1973. We in the pro-life movement are fighting against this normalization of the killing of pre-born babies through abortion. We know with certainty through the 3D and 4D ultrasound that a human being resides in a mother's womb. Our founding political document, *The Declaration of Independence*, says that every human being has an unalienable right to life. Abortion is a fundamental human rights issue. It is the old, old story down through the ages of those with power killing those without it. Slavery, genocide, abortion all spring from the same poisoned well: the end justifies any means; might makes right; the weak can be destroyed by the strong.

The preborn baby is the most innocent and defenseless of human beings. Please help us to continue our educational efforts to end the slaughter by contributing whatever you can afford so that together we can win this fight for all those little ones who cannot defend themselves and whose silent screams from abortion fill the universe.

## FEDERAL LEGISLATION

### In January, 2019, the 116<sup>th</sup> Congress will be split between the Parties:

Senate: Republican majority of around 3

House: Democrat majority of around 30

On Sept. 28, the President signed the Depts. of Defense, Labor, HHS & Education Bill [HR.6157]. This bill includes nearly \$100M to fund research using aborted fetal remains. However, a \$15,900 contract with *Advanced Bioscience Resources* to create mice with ‘humanized immune systems’, was ended. (See Oct 2018 LN, p3) HHS announced an “audit of all acquisitions involving human fetal tissue...” In a letter to HHS Secretary Azar, 50 pro-life leaders said adult stem cells would work as well.

The **ObamaCare “open enrollment period”** runs through 12/15/18. Many plans have a hidden abortion surcharge. To find which plans cover abortion, see: <http://obamacareabortion.com/>

In late Sept., the President was asked if *Roe v. Wade* should be overturned. “Yeah, I don’t want to talk about it now, because that’s a controversy that I’m going to leave to the courts,” he said. When asked a similar question in July, he said, “I don’t think I’m going to be so specific in the questions...and I’m actually told that I shouldn’t be” ....“Well, maybe someday it [abortion policy] will be [returned] to the states, you never know how that’s gonna turn out, that’s a very complex question,” Trump replied.

The Supreme Court may take two cases that ask, “Can a State stop all Medicaid funds to an abortion provider”? (Funds are for non-abortion services). The cases are *Gee v. PP Gulf Coast* and *Andersen v. PP of KS & mid-MO*.

Despite an aggressive 11th hour challenge, Brett Kavanaugh was confirmed as a Supreme Court Justice, 50-48. Those who opposed his confirmation often said they were protecting *Roe v Wade*. But M. Filozof opines that *Roe* (which never said if the ‘right to privacy’ is protected by the 9th or 14th Amendment), is here to stay. Other pundits say Leftists know they created a super-charged SCOTUS to impose much of their agenda, and fear for its future if they lose control. What is Justice Kavanaugh’s likely vote on abortion? Some pro-lifers say we can’t ask how a Judge will rule on future cases. Others say we work so hard on SCOTUS as the way to overturn *Roe* that it is foolish not to know. In Sen. Collins’ speech before her vote, she said Kavanaugh was asked if ‘long established’ precedent should be overturned if five Justices think the original case was wrongly decided. He said *No*, and then claimed that precedent wasn’t just tradition, it was rooted in Article III of the Constitution. Precedent should only be changed, he said, in rare cases where a “grievously

wrong” decision was reached. (See: LN, Sept. 2018, p3) **Planned Parenthood** has already announced plans for a “post-Roe world”, where they fear up to 22 States could ban abortion. Their 3-part “Care for All” plan includes: 1) Expand facilities in abortion friendly states, and help women travel to them. Increase tele-med abortions. 2) Boost lobbying efforts in State Legislatures. 3) Use all forms of media to fight abortion “stigma.” Ironically, PP equates this plan to the “underground RR.”

Writer Ryan O’Hara asks if pro-lifers are ready to ‘step up’ in a post-Roe world, to aid the increased number of needy babies, kids and parents?

David Daleiden says that Planned Parenthood chose Dr. Leana Wen to head PP because their abortion doctors envy the ‘public face’ of PP, and feel disrespected. Dr. Wen, former Baltimore Health Commissioner, targeted CPC’s for years. A Fed. Court awarded \$1.1M to *Greater Balt. Center for Pregnancy Concerns*, to cover legal fees.

**Hawaii’s** law forcing Crisis Pregnancy Centers to display abortion ads was struck down in Sept. by the US District Court in Hawaii. **Louisiana’s** law that abortion facilities must have hospital admitting privileges was upheld 2-1 by the 5th US Circuit Court. A similar **Texas** law, struck down by SCOTUS in 2016, had the added ‘burden’ of requiring doctors to admit a minimum number of patients per year.

A **California** law that all non-profits must give the State AG the name of everyone who donates \$5,000 or more, was upheld by the 9th US Circuit court. The **Alabama** Supreme Court ruled, in *Jessie Phillips v. State of Alabama* that “the value of the life of an unborn child is no less than the value of the lives of other persons.” Justice Parker asked SCOTUS to overturn *Roe*.



## NEW YORK STATE LEGISLATION

The loss of the NYS Senate Republican majority in the 2019/2020 NYS Legislative sessions will make our efforts to defend innocent lives much more difficult. Over the next weeks and months we will have to regroup and strategize on how to deal with this. The one thing we cannot do is give up.

## HEALTH & SCIENCE

### Euthanasia/Assisted Suicide



At the World Medical Association (WMA) meeting this past summer, the Canadian and Dutch Medical Associations (CMA and KNMG) submitted a resolution to reverse the Association's position against Euthanasia. However, they had to withdraw the resolution due to lack of support. The August issue of the WMA's World Medical Journal contained reports on end-of-life care from several regions around the globe. The local Brazilian association stated, "if the doctor is prepared not only to cure but also to kill, the ethics of medical practice and the trust that the patient must have in his doctor will be very battered." The Israeli medical association as well as the associations in the Asia-Pacific region (including Australia, New Zealand, Japan and China) were opposed to euthanasia. The African associations were "unanimously opposed to euthanasia and physician assisted suicide in any form." The German Medical Association joined with the WMA and the Vatican to organize a symposium where a majority of the participants rejected euthanasia "as being diametrically opposed to the ethical principles of medicine and expressed concern that they could lead to misuse or abuse." However, in June, the American Medical Association (AMA) decided not to reaffirm its long-standing opposition to assisted suicide. The AMA voted against the recommendation of its own Council on Ethical and Judicial Affairs (which recommended that the AMA retain its position against assisted suicide). The AMA sent the recommendation back to the Council for further study, which opens the door for a change in position. Euthanasia activists were successful in getting some of the state AMA affiliates to take a neutral po-

sition, allowing some state legislatures to legalize assisted suicide. Patient advocates are concerned that this shift may lead to a push to legalize assisted suicide in more states.

Matt Vallière, Executive Director of Patients' Rights Action Fund stated, "The [AMA's] decision to not confirm their own Council on Ethical and Judicial Affairs (CEJA's) recommendation...does not take into account that this bad public policy puts vulnerable patients at high risk for coercion, mistakes and even abuse. Although the AMA's opposition still stands for now, a referral back to CEJA is a lost opportunity and a failure to stand against a policy that has grave consequences for everyone, but especially persons living with illness, disabilities, or socio-economic disadvantage. Assisted suicide is not medical care." The CEJA concluded, "Physician-assisted suicide is fundamentally incompatible with the physician's role as healer, would be difficult or impossible to control, and would pose serious societal risks."

The American College of Physicians (ACP) stated last year, "The power to prescribe assisted suicide carries a profound potential for misuse and abuse. The creation of a formal role for physicians to assist patients with suicide in an era of health care cost containment is especially troublesome. A broad right to physician-assisted suicide in a country with no general right to health care would be, at best, ironic."

Vallière concluded, "Congress, state legislatures, and medical licensure boards should act to promote access to, availability of, and training in high-level multidisciplinary palliative care and to support both the home and facility based personal care needs of people with chronic life-threatening illness and advanced disability, which under assisted suicide law, qualifies a person as 'terminal.'" - ♥ My skeleton is complete at 42 days and I have reflexes.
- ♥ My brain waves can be detected as early as 43 days.
- ♥ At 8 weeks my brain and all body systems are present and I look like a miniature doll.
- ♥ During weeks 9 & 10 I squint, swallow and can make a fist.
- ♥ By the 11th and 12th weeks I am moving my arms and legs, sucking my thumbs and breathing amniotic fluid. All my systems are working.
- ♥ My movements by 16 weeks are quite active and I can be seen performing somersaults on ultrasound but am not yet felt by my mother.
- ♥ From the 3rd month on nothing new develops. I continue to grow in size and by 20 weeks I have hair on my head, weigh 1 pound and am 12 inches tall.
