This outcome is exactly what has happened in Belgium, the Netherlands and Canada.

Will depressed patients feel they have a real choice given the emotional and financial costs they are imposing on their families? They will feel they have a duty to die and are being selfish by choosing to live. We need your support to stop such anti-life laws.

## FEDERAL LEGISLATION

As of May 7, the next COVID-19 response Bill was being crafted. It would send out more money to allow laid-off workers to keep their employer medical plan, as per the 1985 COBRA Act. But just like the prior **HR.6201**, (See LN, 5/20, p3) Nancy Pelosi is trying to exempt this new bill from Hyde Amendment rules, which ban Federal funds paying for abortions.

Rep. Bradley Byrne [AL-1] wrote that Pelosi is keeping the House shut down while she negotiates multi-trillion-dollar bills with the Administration. Then she calls the 434 'non-essential' House members back to vote *yes* or *no* on the bill. There are no committees, debates, or amendments. There is no chance for members to actually 'represent' their constituents. (See: [www.ALtoday.com/archives/5/4/20](http://www.ALtoday.com/archives/5/4/20))

The Federal Emergency Management Agency issued a Civil Rights Bulletin re Crisis Standards of Care during the current pandemic. Decisions on treatments, or denials thereof, must be made on a bias-free, individualized judgement of objective medical evidence, and the wishes of the patient. HHS's Office of Civil Rights recently put out similar guidelines, in response to reports that medical care rationing was being considered.

The Supreme Court, in early May, heard oral arguments telephonically for the first time. C-SPAN broadcast them live. Their graphics during the May 6 *Little Sisters* case only mentioned contraceptives, not abortifacients or sterilization. Justice Ginsberg summarized the pro-abortion position with questions that stated ObamaCare requires all women can get free contraceptives without lifting a finger. The Sisters argue they can't be "complicit" in their employees obtaining the objectionable products or services, but don't object to an employee using them. This case, and the related *Trump v PA*, (also heard May 6) should have decisions released in late June.

**Abortion Essential or Non-Essential?** The status of which states have closed abortuaries as "non-essential" is ever changing and will become moot as states begin to reopen. Most likely, the 'blue' states will open last, but few have closed their abortion centers. Perhaps a future Court challenge of *Roe* will grow from a state that exercised its 'emergency' control of abortion.

**Children of God for Life** has updated its list of ethical Corona vaccine developments. *Sanofi Pasteur* and partner *GSK* are not using aborted cells. Same for *Inovio*. But *J&J* and its partners, *CanSino*, *Moderna*, U of Pittsburgh, and U of Oxford and its partners, all use unethical cells. The **Charlotte Lozier Institute** also has an Ethics Assessment of Covid-19 Vaccine Programs. William Orrick, the judge in **David Daleiden's** defamation suit vs Dr. Savita Ginde, released three (unredacted) 2012 invoices showing that Planned

Parenthood Mar Monte billed Stem Express \$55 per fetal organ and \$10 per maternal blood sample. Redacted invoices were released in 2016, after the House investigated David's original Planned Parenthood videos. Daleiden et al appealed the \$2M judgement against them in a prior RICO and trespass case vs. Planned Parenthood.

**Red Rose Rescue** has rescheduled its first National Conference for Nov. 6 - 7, 2020, in St. Louis.

The *Reuters* 'style guide' instructs reporters to use "aborted fetus", not "aborted baby". However, their April 27 story on disruptions and euthanasia in the meat supply-chain had no problem calling aborted pig fetuses "piglets", "baby pigs" or "victims."



## NEW YORK STATE LEGISLATION

New Yorkers for Constitutional Freedoms reported that Governor Cuomo's Executive Order 202.23 canceled state legislative special elections (including LI's 12<sup>th</sup> Assembly District) that were scheduled for June 23. Following this, the NYS Board of Elections canceled the June 23 NY Democratic presidential primary saying the primary was not necessary, especially given the health concerns due to the pandemic. After suspending his campaign, Bernie Sanders wanted to remain on the ballot in all remaining primaries to maximize his delegate count. A lawsuit filed by former candidate Andrew Yang claimed his rights were violated when his name was removed from the NY primary ballot. US District Court Judge Analisa Torres ruled all qualifying candidates had to be reinstated on the ballot. The decision stated that canceling the primary deprived candidates of "the opportunity to compete for delegate slots and shape the course of events at the Convention... The loss of these First Amendment rights is a heavy hardship."

All congressional and NYS Assembly and Senate primary elections will be held on June 23. School Board elections have been postponed until June 9 and will be held by absentee ballot only, as well as public library elections. All village elections have been rescheduled until September 15.

Executive Order 202.23 also required that all voters be mailed an absentee ballot for the primary. Executive Order 202.26 modified the requirement. Absentee ballots will be mailed upon request to any voter who is eligible to vote in the primary. The purpose is to allow NY voters the option of protecting themselves from the coronavirus by not visiting the polls. In-person voting for the June 23 primary remains available as of this writing.

The **LICL sent Candidate Questionnaires** to all June 23 House of Representative primary candidates. No replies were received as of May 7.

## HEALTH & SCIENCE Planned Parenthood



Recent news reports indicate that Planned Parenthood will not receive funds from the Payroll Protection Program, which is intended for small businesses with less than 500 employees affected by the pandemic. PP has 50+ affiliates in the US and employs over 16,000 people. (Nancy Pelosi is still attempting to get funding for PP in future bills.) In April, Planned Parenthood of Greater New York announced the closing of 12 locations due to the financial strain of the pandemic. These centers include Glen Cove, Massapequa, the Bronx, Staten Island, and the mobile health center operating out of Nassau County.

Yet even as PP reduces their physical presence, they are aggressively working to increase their customer base and online activities. On May 1, Judy Brown at all.org noted that Dr. Sara C. Flowers, V.P. of Education at Planned Parenthood Federation of America, is using the pandemic to promote PP's resources. PP is reaching out to parents to 'help' with the "birds and bees" conversation, since children are not currently in the classroom for "sex-ed/health" classes. One of PP's projects is their sex-ed chatbox, Roo, which was introduced in early 2019. PP considers it their alternative to insufficient sex ed programs in schools. When the number of teens accessing Roo didn't meet PP's projections, they turned to the advertising agency R/GA to get more children to ask Roo questions. Since 69% of 13-18-year-olds watch online videos every day, the advertising agency created a YouTube series, Roo High School. The videos use YouTubers with large numbers of subscribers to promote the chatbox. PP is targeting teens "who live in conservative communities who often face challenges getting accurate and nonjudgmental answers." (fastcompany.com, 4/28/20). Judy Brown stated, "Roo High School is a propaganda bonanza for Planned Parenthood."

In late April, over 130 members of Congress filed an amicus brief at the Supreme Court. On 4/30/20 CNA reported the brief "argued that states should have the flexibility to determine qualified Medicaid providers" and "urged the Supreme Court to hear South Carolina's case on barring Planned Parenthood from receiving Medicaid reimbursements." Rep. Jeff Duncan of SC stated, "This is a battle on two fronts – a fight for the unborn and the conscience of taxpayers, and a fight for states' authority to decide which providers qualify for funds." Pro-life groups supported the brief as well. Rep. Ralph Norman of SC noted that even though the Hyde Amendment prohibits taxpayer funding of elective abortions in Medicaid, any public funding of PP for other services frees up resources to dedicate to abortion. Norman said, "For Planned Parenthood, that means Medicaid reimbursements for approved services would, in part, support the same overhead and broader operational costs that makes their life-ending abortion 'services' possible." Ac-

ording to their annual reports, PP's government funding has increased in the last two years. From 2011 to 2017 PP's government funding remained relatively constant. The Heritage Foundation announced in April that government funding for Planned Parenthood doubled from 2006 to a high of over \$616 million in FY 2019.

Judy Brown of American Life League reports (Pro-Life this Week, 5/1/20) that 4 PP affiliates covering six states are "participating in a study that is attempting to show that it is okay for mothers to decide to have an abortion and then get a prescription for the abortion pills without ever having to go to a PP facility." The woman teleconferences from her home; then the abortion pills are mailed to her. This is a direct violation of the FDA approved procedure, requiring the woman to physically have an appointment at PP before receiving the pills in person. Brown noted, "This is all part of the scheme by the abortion industry – led by Planned Parenthood – to move abortions from physical centers to homes on your block." Pam Belluck reported at the New York Times on 4/28 that this 'innovative' method, TelAbortion, "allows women seeking abortions to have video consultations with certified doctors and then receive abortion pills by mail to take on their own." Gabriel Hays reported at LifeNews.com on 4/29/20 that this method of abortion has expanded rapidly. Last year 5 states allowed it. Early this year there were 13, including NY. Illinois and Maryland "jumped on the bandwagon as the coronavirus crisis exploded." Tony Perkins of Family Research Council reported on May 5 that PP announced that its telehealth operations were available in all 50 states by the end of April. Hays notes that even though "TelAbortion is currently trending due to coronavirus shutdowns, it has been approved by the FDA for the last 20 years. Current regulations require the first drug to be "dispensed in clinics or hospitals by specially certified doctors or other medical providers." The "TelAbortion" method is exploiting the loophole that the FDA doesn't require in-person consultation between patients and doctors. So, women are having a virtual meeting anywhere with a 'certified doctor' based elsewhere.

How can a doctor confirm the gestational age of the pre-born child without a physical exam? The abortion pill regimen is only indicated through 10 weeks gestation. In addition, a woman is supposed to have a follow-up visit 2 weeks after the chemical abortion to be sure the abortion was 'complete' and there are no complications. Is this follow-up visit occurring? Chemical abortions have a 5-10% failure rate, which may result in an additional surgical abortion. PP sells the regimen as simple, natural, safe and private. However, many women have suffered severe hemorrhaging, requiring hospitalization. Additionally, the trauma of delivering the child and 'flushing it down the toilet' has severely affected many women. Perkins stated, "Staying home is supposed to keep people safe. But for unborn babies, even lockdowns have their risks."

Women who change their minds after taking the first pill in the regimen, mifepristone, may be able to save their child using the abortion pill reversal method. They are given progesterone, the natural hormone necessary to nurture and sustain a pregnancy. This extra prescribed progesterone is given in the hopes of overpowering the effects of mifepristone. Mifepristone binds to progesterone receptors in the uterus and placenta, resulting in the preborn child's death. The extra progesterone is usually prescribed through the first trimester. 


