Healing the Shockwaves of Abortion MARCH: Healing the Grandparents

Grandparents are often directly impacted by an abortion loss, but rarely given consideration when we look at the complicated grief after abortion. They may have convinced their son or daughter that this was the best course of action and/or threatened rejection and abandonment if their daughter continued with the pregnancy. They may have tried but were unable to prevent the death of their grandchild (a traumatic loss) or only learned of the abortion after the event.

Grandparents need to hear a confirmation that they suffered the loss of a grandchild and, depending on their role in the event, may have some unresolved feelings of grief, guilt, and anger from this loss. Family secrets and these unspoken and powerful emotions can wreak havoc on family life. If the abortion of their grandchild was experienced as a traumatic loss they may suffer depression, anxiety, sleep disturbance, addiction and other common symptoms of trauma.

While this is an event in the past, it may be impacting their lives, health, family relationships and relationship with God.

Defunding Planned Parenthood: PP's 2014/15 Annual Report stated that Planned Parenthood Federation of America received \$553.7 million in taxpayer money (local, state and federal government programs). A May 2015 report issued by the Government Accountability Office identified the following sources of funds to PP:

- *Maternal and child health services block grant (Title V) to the states – Health Resources and Services Administration
- *Family Planning Services (Title X) – Office of Population Affairs
- *Social Services block grants (Title XX) – Administration for Children and Families
- *Family Planning improvement grant – Office of Population Affairs
- *Teen Pregnancy Prevention Program (TPPI) – Office of DHHS Secretary
- *Affordable Care Act personal responsibility (sex education) – Administration for Children and Families
- *HIV prevention activities – Centers for Disease Control and Prevention
- *Medical assistance program – Centers for Medicare & Medicaid Services
- *Housing opportunities for persons with AIDS – Housing & Urban Development
- *Community development block grants/entitlement grants – HUD
- *Crime victim assistance – Department of Justice
- *Violence against women formula grants, archived, reinstated – Department of Justice

FEDERAL LEGISLATION

GOP leaders in Congress began using the Budget Reconciliation Process to, among other things, defund Planned Parenthood.

“Reconciliation” sets a framework of goals, which allow Federal spending bills to pass the Senate with 51, not 60 votes. In January, both

Houses passed Senate Concurrent Resolution 3, the first step in the process. Specific bills are then debated and passed to ‘fill in’ the framework. One such bill is the Defund Planned Parenthood Act, HR.354. However, American Life League cautions this bill has many loopholes. There is also the Defund Abortion Providers Act, HR.853.

Reconciliation will also be one means toward repeal of ‘ObamaCare’, and the related Health Care and Education Reconciliation Act of 2010 [HCERA]. Several bills have already been introduced to totally repeal or limit portions of ‘ObamaCare’. NOTE: LICL objects to ObamaCare because parts in it include abortion coverage & abortifacient/sterilization /contraception coverage at taxpayer expense, and direct or implicit limiting of care to vulnerable populations such as sick newborns and terminally ill”.

On Jan. 24, the House passed the No Taxpayer Funding of Abortion Act [HR.7/S.184]. It makes permanent the ‘Hyde Amendment’, banning federal funds from being used to fund Medicaid abortions. It also removes abortion funding from ‘ObamaCare’, as its future is debated. [King, Zeldin - yea; Meeks, Rice & Suozzi - nea]

Pres. Trump signed a Presidential Memorandum to reinstate the “Mexico City Policy”, which bans US funds to international agencies that perform or promote abortion. For the last 30+ years, this policy has switched back and forth each time the Party in the White House changes.

President Trump named Judge Neil Gorsuch as his Supreme Court nominee to replace Justice Antonin Scalia. The Senate Judiciary Committee will now begin confirmation hearings, followed by a full vote in the Senate.

Judge Gorsuch is known for his controversial decision in the Hobby Lobby case. He wrote that those with “sincerely held religious beliefs” should not be forced to participate in something “their religion teaches them to be gravely wrong.” Gorsuch joined in the majority decision in the Little Sisters of the Poor case which stated, “All the plaintiffs in this case sincerely believe that they will be violating God’s law if they execute the documents required by the government. And the penalty for refusal to execute the documents may be in the millions of dollars. How can it be any clearer that the law substantially burdens the plaintiff’s free exercise of religion?” In a dissenting opinion in the Planned Parenthood Association of Utah v. Herbert case, Gorsuch wrote in the dissenting opinion, “We now have video where they’re [Planned Parenthood] selling fetus body parts for money and it’s an outrage...So for coloring outside the lines, Planned Parenthood forfeits some of their benefits...It is undisputed...that the Governor was free as a matter of law to suspend the funding in question.” Gorsuch also authored the book entitled “The Future of Assisted Suicide and Euthanasia.” In chapter nine he wrote, “Human life qualifies as a basic good. It follows that we can and should refrain from actions intended to do it harm...To act intentionally against life is to suggest that its value rests only on its transient instrumental usefulness for other ends.”



NEW YORK STATE LEGISLATION

Governor Cuomo is pushing for an amendment to the NYS Constitution to permit abortion on demand in New York in case Roe v. Wade is overturned. Cuomo's pro-abortion amendment to the NYS Constitution requires majority votes in both the assembly and state senate by two separately elected legislatures and only then does it go to the voters for a vote. The earliest that could happen is 2020.

Among bills facing legislative action in 2017 are the Comprehensive Contraception Coverage Act (A.1378-Cahill) which would compel all group health insurance policies to cover birth control and abortifacient drugs without cost or restriction. Also pending is the Legalization of Physician-Assisted Suicide (S.3151-Savino/A.2383-Paulin), and the Reproductive Health Act (S.2796-Krueger/A.1748-Glick)

A Legislative Day is scheduled in Albany on March 21, 2017, with special speakers and activities with legislators. Registration and fees are required. For more info see: <http://legday.newyorkfamilies.org/>

HEALTH & SCIENCE

Science Fiction Becoming Reality



David A. Prentice, Ph.D. wrote an article entitled “O Brave New World” which appeared in the January 2017 edition of *Columbia*, the K of C magazine. He warns that “threats to the dignity of human life...have rapidly multiplied and taken new forms that read like the most fanciful science fiction. What used to sound like cinematic nightmares are now becoming reality.” Prentice reports that the first “three-parent baby” was born in April 2016. “The boy was conceived in a laboratory environment, using genetic material from two mothers and one father. The laboratory technique, a form of cloning, is supposedly designed to ‘treat’ potentially lethal genetic mutations in mitochondria, little energy factories in every cell that contain their own DNA. Since all mitochondria are inherited from a mother’s egg cell, this form of artificial reproduction combines parts of multiple eggs or embryos in the laboratory to create new human beings, free of mutated DNA. Yet there is a tremendous ethical flaw: No one is actually *treated*. Instead, new, ‘better’ individuals are constructed as a replacement for those carrying any defect.

“Gene editing of embryos is also proposed as a way to rid the human race of terrible genetic conditions. Specific enzymes are added to the early embryo, to cut and replace particular DNA regions. Genetic engineering was attempted in the past, but new, more accurate enzymes have brought human gene editing closer to reality. Genetic manipulation of embryos treats human life instrumentally rather than as an end in itself. Numerous young lives are destroyed in the experiments, and human life becomes a commodity to be constructed based on desired ‘features’. Moreover, embryo genetic changes are ‘germline’ – heritable alterations that can be passed on to future generations, with unknown consequences.”

Prentice goes on to state that there are legitimate uses of gene editing tools that “focus on benefiting born human beings and thus avoid the creation, manipulation and destruction of human embryos. One example is gene editing to supercharge immune cells [to treat leukemia] ... Since ethical gene-editing techniques offer real promise to patients, pro-life legislation has been advanced to channel science into ethical, lifesaving efforts.” Prentice noted that the NYC doctor responsible for the first three-parent baby worked in Mexico to avoid the legal restrictions in the US. “The Aderholt Amendment (2016) effectively prohibits three-parent and gene-edited embryo experiments but allows for ethical genetic therapies or trials. Dr. Prentice warns that “such legislation is essential as proponents of cloning and embryo manipulation technologies continue to push ahead on radical and morally problematic ideas.” The most important ingredient in the creation of an embryo is the egg. Many eggs are needed in cloning and three-parent embryo creation because the process often fails. Scientists are now creating artificial mouse eggs using some of the rodent’s skin. The process starts with the ethical technique of creating pluripotent stem (iPS) cells, which look and act like embryonic stem cells but do not involve the destruction of an embryo. The cells are formed by adding a few genes to the skin cell to reprogram the cell. Proteins are then added to stimulate them to form immature egg cells. The immature eggs are incubated with fetal tissue to mature

the eggs. The eggs are then fertilized with mouse sperm. Prentice stated that this process will not be possible for humans any time soon. He warns that the artificial mouse eggs produced many abnormal animals. The successful birth rate was less than 1%. Some scientists are hoping to eventually mass-produce laboratory-generated human beings – which Prentice notes “treats human life as a manufactured commodity, not as something of inherent worth.

“Laboratory-constructed human embryos already exist, and there is now a push to gestate them in artificial wombs. Scientists in the US and the UK have succeeded in growing human embryos in the laboratory for far longer than ever achieved before, and are now pressing to go further – bringing to mind the hatcheries of Aldous Huxley’s novel *Brave New World*.

“With normal procreation, human embryos implant into the uterine lining at about seven days after conception, establishing their umbilical link to their mother for nutrition and oxygen. Laboratories have now grown human embryos well past that point, to 13 days after conception. Such experiments treat human beings as research fodder; embryos are destroyed once the research results are achieved. Current US law does not regulate human embryo research other than restricting federal funding, but this type of unethical abuse needs to be addressed legislatively or by executive order.”

H.G. Wells’ novel *The Island of Dr. Moreau* deals with “chimeras”, creatures that are a mixture of two or more species. US scientists are now creating human-animal chimeras. The National Institutes of Health (NIH) proposes to fund more of these experiments, pushing the ethical boundaries. Prentice points out that not all chimeras are unethical. Pig heart valves are implanted into humans, and the “oncomouse” containing human genes is used to study cancer. However, Prentice warns that the NIH plans “violate ethical barriers, all the while based on questionable science. Some propose trying to grow transplantable human organs in farm animals, while others want to study human cells developing in animals. While such experiments could be done following noncontroversial procedures, NIH proposes adding the human cells to very early-stage animal embryos. At such an early stage of development, the human cells could become anything, including human eggs or sperm, or even a complete human brain. These experiments clearly cross the line. What is the status of an animal with a human brain? What could happen if two animals producing human gametes breed and gestate a human? What other aspects of humanity could be breached and sow ethical confusion?” NIH may move ahead with its plan even after receiving thousands of comments opposed to its proposal to fund human-animal chimera experiments. Congress has proposed legislation to prohibit unethical chimera creation, but nothing has become law. Prentice concludes, “It’s time to foreclose unethical research and channel efforts into scientifically valid, ethically framed alternatives - to science that values each and every human life, rather than harming or killing some to advance the well-being of others. For the sake of the common good, it is our duty to raise our voices in defense of the most vulnerable.”


