

**Protecting EVERY Preborn Child:** Judie Brown of American Life League wrote two Commentaries recently (1/24/23, 1/31/23) reflecting on our need to stay focused on protecting every single preborn child. She emphasized that we need to be very clear we march to "protect all mothers and every one of their little babies." Brown asked, "What exactly have pro-life Americans been doing for 50 years? Well, apparently anything but fighting for human personhood without exceptions from the moment the human being begins! That is really not complicated! But if it is, the question is why? What are we really doing? Maybe it's not politically correct, but who cares?" She goes on to note that Nellie Gray, the founder of the March for Life, knew what it meant to be pro-life, "and gave no apologies for her position, telling anyone who ever interviewed her one simple thing: **"No exceptions! No compromises!"** Judie Brown said the reason Nellie said that and meant it "with every bone in her body was simple... We are talking about the babies, and either we work to protect every innocent human being, or we are not pro-life!" In 1998 Nellie Gray said, "The battle will not be won until the entire anti-abortion community and every community of faith works relentlessly to establish personhood for the preborn children." Brown said, "...it is time to put the focus back where it should be. That is on the science that supports human personhood... No more moral relativism, please. Just the facts. That is all we need to succeed in teaching and legislating the simple truth that every single innocent human being matters. We will not leave one of them behind!" Brown acknowledged there's "nothing wrong with 'Building a Post-Roe Future', but we must keep our focus on ending the "killing of babies... We are anti child-killing people, not community organizers! And yet there it is, the lamest gobbledygook in a world somehow wedded to the idea that politics is where it's at, babies be damned! And I for one cannot abide any of this. There are thousands of little ones dying right now despite the *Dobbs ruling*, and everyone knows it. After all, Dobbs is a states' rights decision, not by any means a final victory for the innocents." Brown declared that we must complete the task of saving EVERY preborn child first, without accepting any "lame excuses... We strive to do amazing things by relying on God and defending every single one of His babies."



## FEDERAL LEGISLATION

The House (re)introduced many pro-life bills in January, some with Senate companions:

**HR.7/S.62** *No Taxpayer Funding for Abortion & Abortion Insurance Full Disclosure Act* (i.e: does policy cover it)  
**HR.128 & HR 371** *Defund Planned Parenthood Act of 2023*. Identical bills; 371 has more cosponsors [NY- none]

**HR.175** *Heartbeat Protection Act* ~6-week abortion ban  
**HR.279** *(Pharmacist) Conscience Protection Act*  
**HR.372** *Protecting Life and Taxpayers Act* No federal funds for any organization that performs or aids in an abortion.

**HR.427/S.95** *SAVE Moms and Babies Act* to impose tighter FDA rules on current and future abortion drugs.

**HR.461/S.18** *Protecting Individuals With Down Syndrome* to ban abortions based solely on a Down diagnosis.

The House passed **HR.26**, the *Born-Alive Abortion Survivors Protection Act* by 220-210 (Reps. D'Esposito, Santos, Garbarino, LaLota - Yea ) on Jan. 11. The bill is now in the Senate. Radio host Larry O'Connor commented: "A 'botched abortion' is also known as 'childbirth'."

An attempt to replace **HR.26** with the anti-life *Women's Health Protection Act* failed.

Also passed was **H.Con.Res.3**, to condemn violence against pro-life facilities, organizations, and houses of worship. The House authorized a Subcommittee on the Weaponization of the Federal Government. Their investigations will include the targeting of pro-lifers.

A 2019 rule barred funds to organizations which force healthcare workers to violate their conscience. Lawsuits and court cases kept the rule from taking effect, but the 5<sup>th</sup> and 8<sup>th</sup> Circuit Court of Appeals upheld the rule. The HHS says it wants to end the rule and restore the old way they balanced the rights/needs of patient v. provider.

On Jan. 4 the US Dept. of Justice said the Post Office and other mail services can handle abortion drugs, despite state bans after the Biden administration allowed the drugs to be sold at pharmacies or sent by mail. Previously, only supervised medical facilities could dispense *mifepristone*. Rite-Aid, CVS and Walgreens announced plans to carry the drug where state law allows. A Walgreens shareholders meeting saw protests over the policy. On Feb. 4, pro-lifers were outside some of the 'big 3's' stores nationwide.

Jan. 14: US District Court (Oregon) Judge Ann Aiken found "one narrow exception" to Title IX, that permits religious universities to receive federal funding even if they follow religious beliefs that some have challenged in court as sex-based discrimination.

Florida may lower their abortion ban to 12 weeks. The governor stated if drug stores provide abortion pills as per new FDA rules, he will prosecute them under state law. A California judge tossed a state law that allowed people to sue gun manufacturers. CA will now use this ruling to go after Texas' SB8 law ('private right of action' against abortionists). Minnesota passed a state 'right to abortion' bill.

The Satanic Temple announced it will open a New Mexico abortuary (named after Samuel Alito's mother) to

do ritualistic abortions.

A recent study published in *Contraception* provides strong evidence that pregnancy help centers offer better and less expensive services than abortion facilities, including shorter wait times, same-day appointments, and free pregnancy tests and ultrasounds. (LifeNews.com 2/6/23)



## NEW YORK STATE LEGISLATION

CDC data reports 63,142 abortions in NYS in 2020, including 37,523 procedures in NYC.

The Democrats kept their supermajority in both the NY State Senate and Assembly.

The NY legislature passed the **Equality Amendment to the NY Constitution [S.108a/A.1283]** for the 2<sup>nd</sup> time. It bans discrimination, based on sexual issues, or against 'reproductive healthcare,' aka abortion. The last chance to block this amendment will be when it is on the ballot in **2024**, when they expect more voters due to the presidential election. Senators from Districts 4, 6, 7, & 9 voted YES, as did Assembly members from Districts 1, 6, 10, 11, 13, 16, 18 & 22. Dist. 14, 15 excused.

Governor Hochul's State of the State address called for shielding abortion seekers' internet searches/phone locations, having abortion pills at or near all SUNY/CUNY campuses, and letting pharmacists directly prescribe the abortion pill, stating it "is safer than Tylenol." (The FDA has linked the abortion pill to at least 28 women's deaths and 4,000 serious complications between the years 2000 and 2018. Under President Obama, the FDA stopped requiring that non-fatal complications be reported. Given that over 50% of all abortions are now chemical abortions, these numbers are certainly much higher. Studies indicate that as many as 1 in 17 women require hospital treatment after a chemical abortion.)

Albany bills of concern include:

**S.348B** *Reproductive Freedom & Equity Grant Program* to increase and expand abortuaries and aid 'abortion tourists.'  
**S.1043** *Facilitates Access of Self-Administered Birth Control* okays "non-patient specific" abortion pill prescriptions.  
**S.1066** *Protections for Health Care Providers* broader reproductive care protection, not just termination services. (abortionists+)  
**S.1003A** *Healthcare Facility Transparency Act* Hospitals must inform you if they exclude the kind of "care" you seek.  
**A.117** to add "Embryo" to the definition of "tissue" for purposes of tissue storage.

## HEALTH & SCIENCE

Doctor-Prescribed Assisted Suicide/  
Medical Aid in Dying/Euthanasia



As reported on page 3 of this newsletter, the “Medical Aid in Dying Act” has been reintroduced in the NYS Legislature and is currently in the Assembly and Senate Health Committees. This bill would add a new section to the Public Health Law allowing physicians to prescribe lethal doses of medication specifically to end a patient’s life. Will this bill lead to a slippery slope as many have warned? We just need to look at Canada for an answer.

In 2015, Canada’s Medical Assistance in Dying bill (MAiD) was passed as a limited program for patients with an irreversible, terminal, and painful illness. It has now been expanded to include those with an “intolerable” condition. Advocates of MAiD want to further expand it for the mentally ill and “mature minors”. Last year, five Canadian veterans testified they had been offered euthanasia or assisted suicide (EAS) instead of the care they requested. Retired Corporal Christine Gauthier said a case worker offered to provide a euthanasia device when she asked for a stairlift for her home. Individuals applied for MAiD because they lacked housing. Family members were told there was a one-year wait for an appointment for psychiatric care (despite a serious psychiatric history). However, others can make an appointment for MAiD within two weeks. Teresa Lynch, who worked in oncology for years, stated that EAS legislation is a threat to the “vulnerable elderly and the disabled who are against a change in the law... It is naïve to imagine that [introducing EAS in the UK] would not be associated with pressure being applied to people to ‘save the NHS’, or even their impoverished relatives. Accounts of cost savings, together with the threats of hospice defunding in Canada if this “option” is not made available, are chilling. Many doctors and nurses would not agree to becoming agents of the state should the law change.”

Jeremy Appel, a Canadian journalist, supported MAiD. Now he has reservations. He wrote in *Jacobin* magazine, “...the cavalier way in which MAiD has been implemented in Canada serves as a form of eugenics, where only the able-bodied survive.” In December, three human rights experts wrote in *The Telegraph* that Canada’s MAiD law had a “discriminatory impact” on people with disabilities. Law professor Theresia Degener stated, “The implication of (Canada’s) law is that a

life with a disability is automatically less worth living and that in some cases, death is preferable.” Tim Stainton, director of the Canadian Institute for Inclusion and Citizenship at the University of British Columbia said MAiD was “probably the biggest existential threat to disabled people since the Nazis’ program in Germany in the 1930’s”.

In 2021, 10,064 people ended their lives in Canada by assisted suicide or euthanasia, an increase of 32% over the previous year. In the latest report on MAiD from Health Canada, 17.3% of the people cited “isolation or loneliness” as a reason for wanting to die. 35.7% believed they were a “burden on family, friends, or caregivers”. Madeleine Li, a psychiatrist who helped hundreds die, says Canada has gone too far: “Making death too ready a solution disadvantages the most vulnerable people, and actually lets society off the hook. I don’t think death should be society’s solution for its own failures.”

Michael Cook, editor of Bioedge, reported (11/15/22) on a paper by David Albert Jones of the UK’s Anscombe Bioethics Center. Jones reviewed several studies from Europe, Canada and the US in peer-reviewed journals, and his paper, “*Suicide Prevention: Does Legalizing Assisted Suicide Make Things Better Or Worse?*”, compared rates of EAS with rates of self-initiated deaths. The Swiss organization Dignitas argues that having “the option of an assisted/accompanied suicide without having to face the severe risks inherent in commonly known suicide attempts is one of the best methods of preventing suicide attempts and suicide.” Jones found non-assisted suicide rates also increased with the increased rates of EAS. Cook stated it is a controversial finding, but what can’t be denied is “...whatever ‘good’ legalizing EAS might do, it does more harm than good...The introduction of EAS into law and medical practice is therefore a threat to suicide prevention.”

Right to Life UK spokesperson Catherine Robinson stated, “Assisted suicide and euthanasia are not treatments. They are not an attempt to cure a disease, heal a patient or palliate symptoms. Death is not a treatment and medical professionals should have no role in administering or encouraging it. Canada’s lax laws in this regard are a shameful corruption of the medical profession. The expansion of this law to children is a further disgrace and great sadness. The legislation should not just be delayed but completely scrapped. As the data from Canada and Oregon show, many of the reasons that people provide for wanting to end their lives have nothing to do with medicine or physical ailments but ‘relate to psychological, social, and familial problems. Such people need support and assistance to live, not ‘assistance to die.’”




