
## THANK YOU LONG ISLAND PRO-LIFERS!

## Pro-life Work Recognized

John Leland published an article in the New York Times on July 14<sup>th</sup> highlighting several local pro-lifers who have been fighting to protect the unborn for 50+ years. Jane Gilroy began her pro-life activism in 1969 when she learned the NYS Legislature was going to legalize abortion. With her church group, she began to organize trips to the NYS Capitol in Albany to lobby against the bill. This group was instrumental in forming the NYS Right to Life Party. Jane petitioned to run for governor on the RTL Party Line, but 3,000 signatures on her nominating petition were excluded. The NYS Legislature voted to repeal the 1970 abortion law in 1972, but Gov. Rockefeller vetoed the repeal, and a year later came the *Roe* decision. She stated, "They thought...we would go away. But we persisted. We prayed together and we talked to each other, and we just learned more and more. That gave us consolation...[the *Dobbs* decision] is enlivening the conversation...I don't know that it will be changed in my lifetime, but this is a little bit of a start."

Phyllis Graham was shocked when she saw the headlines in January 1973 regarding the *Roe* decision. She worked with a church group to send buses to Washington, DC every month to lobby for a constitutional amendment to ban abortion. As she lobbied, she realized the politicians/staffers weren't listening. She decided that prayer was the only answer. They prayed in the hallways. She campaigned against the Equal Rights Amendment, which was an attempt to solidify abortion 'rights'. She had a weekly radio show on WALK, and participated in weekly vigils at abortion sites. Phyllis said she didn't celebrate after hearing about the *Dobbs* decision but felt a "deep peace". As for what lies ahead, she reflected, "I keep praying every day that God's will be done."

Theresa Bonopartis had a legal abortion in NY prior to the *Roe* decision. She felt pressured by her father to have the abortion. She suffered afterwards with depression and anxiety. After getting help from a priest and therapist, she founded Lumina, an organization based in Westchester that provides post-abortion help. She disagrees with the American Psychological Association's position that having an abortion is not linked to mental health issues. 200 women call Lumina each year looking for help. Lumina provides referrals to mental health professionals and spiritual counseling. Regarding the *Dobbs* decision, she said women "should be angry about what abortion has done, not about overturning *Roe v Wade*."

We are grateful for these women and their dedication to the preborn, as well as the many other individuals who continue to fight for the preborn. We also remember all those who have gone home to God who worked so tirelessly for the preborn.

## FEDERAL LEGISLATION

On June 24, (the eve of Nellie Gray's birthday – the founder of the National March for Life), SCOTUS released **the *Dobbs v Jackson* decision**. It was almost identical to the draft, which was leaked in early May by a still-unidentified person. The Court upheld Mississippi's 15-week

abortion ban 6-3 but ruled *Roe* "egregiously wrong" 5-4. Roberts hoped to save **both** the 15-week ban **and** *Roe*, thus siding with the pro-abortion justices in the second instance. A late July news story claimed the leak ended Roberts attempt to sway other justices to his view. This could also redirect the search for the leaker from a *Roe* supporter to a *Roe* foe.

Justices Breyer, Kagan, & Sotomayor's dissent claimed Justice Alito's majority opinion said: 'If the people who ratified the Bill of Rights, Constitution & 14<sup>th</sup> Amendment didn't know reproductive rights were in there, then neither do we'. The 3 dissenters concluded: "But, of course, "people" did not ratify the Fourteenth Amendment, men did."

On June 8, despite unclear constitutionality, Democrats urged a Biden Executive Order, that would: use tax money to push abortion, and give vouchers to women for out-of-state abortions; boost abortion drug access; create an HHS "reproductive health ombudsman" to "educate" the public; allow abortions on military bases or other Federal lands in all states; and grant Federal employees paid abortion leave.

HHS later said they seek to work with many 'partners' to support abortion access. 'ObamaCare' still covers contraceptives/abortifacients. However, coverage for Natural Family Planning is gone.

On July 11, HHS said that under the EMTALA law, if an ER doctor determines a pregnant patient would be treated best by an 'emergency abortion', it must be done, despite state law. (The Texas AG said he'll fight this rule). HHS also said all pharmacies that get Federal funding must serve women who seek 'reproductive health' prescriptions. There is even a government website where teens can learn where to get free abortions without parental knowledge or consent.

On July 8, Pres. Biden urged Congress to legalize abortion up to birth. Then, refusing a suggestion he declare a National Health Emergency under the PREP Act, on July 11 Pres. Biden issued an Executive Order to 'prevent' what fearmongers claim will happen, post-*Dobbs* - e.g.: no contraceptives, doctors punished for treating miscarriage or ectopic pregnancy, and people unable to get a methotrexate Rx for their Lupus, since that drug is also an abortifacient. An August 3 Executive Order tells HHS to 'explore' using Medicaid to fund out-of-state abortion travel. Could this be considered a violation of the Hyde amendment?

In addition to calls to 'pack the Court' or impeach the Supreme Court Justices, members of Congress introduced the following anti-life bills:

**HR.7945/S.4354- *Military Access to Reproductive Care & Health*** Allows government-funded abortion on military bases.

**S.4504 - *Freedom to Travel for Health Care Act*** Ensures out-of state abortion travel and shields abortion provider. (Sen. Lankford noted: no state has banned such travel).

**HR.8297 *Ensuring Access to Abortion Act*** Similar to above; mandates legal abortuaries serve 'out-of-staters'.

**HR.8373/(S.4557) *Right to Contraception Act*** Bill also allows *Title X* family planning & abortuaries under the same roof, and cements PP funds into law.

**HR.8296/(S.4132) *Women's Health Protection Act- '22*** (brought up for a third time) would end almost every state pro-life law.

**HR.8296, HR.8297, and HR.8373** passed the House in July. Local Reps voted: {Meeks, Rice, Suozzi -*yea* ||| Garbarino, Zeldin - *nay*}

Sen. Rubio, et. al., introduced two pro-life bills, as part of his umbrella '*Providing for Life Act*'. They are:

**HR.8362/S.4512- *Unborn Child Support Act*** Pre-birth Child Support. Boosts Child Tax Credit & adoption help.

**HR.8384/S.4541- *Standing with Moms Act*** To create Federal *Life.com* – a resource for pro-life services and information.

Also introduced: **HR.8584/S.4538 - *Pregnancy Resource Center Defense Act*** to increase fines for attacking PRC's and churches.

In June, Democrats in Congress asked Google to adjust their algorithm so that a search for 'abortion' doesn't turn up "anti-abortion mis-info" sites. A month later, 17 red State AG's told Google not to do that. But Democrats in Congress were already questioning the makers of software that tracks, and can report, students' online activity. Senators wanted a promise that searches for 'abortion', 'contraception', PP, etc., won't be used to penalize kids seeking "healthcare".



## NEW YORK STATE LEGISLATION

Bills passed in Albany: **A.9687b/S.9079b-** ban professional misconduct charges for abortionists who serve women from states that ban abortions. **A.9718b/S.9080b-** medical malpractice insurers can't punish an abortionist who provides a legal service. **S.5400/A.6334, the THRASH Bill,** (to punish hospitals that don't do abortions), did **NOT pass** in Albany. Gov. Hochul has given NY abortuaries \$25M to improve 'abortion access', and \$10M for security. Despite attacks, NY's Pregnancy Resource Centers get \$0.

ECTOPIC PREGNANCIES,  
MISCARRIAGES AND SAVING  
PREGNANT WOMEN'S LIVES



On July 20, 2022, Newsweek carried an opinion piece authored by Dr. Christina Francis, MD, a board member and CEO-elect of the American Association of Pro-life OB/GYNs, and Catherine Glenn Foster, J.D., president, and CEO of Americans United for Life. They wrote, “We are now living in a post-*Roe v. Wade* America, and women are already being bombarded by heavy-handed pro-abortion messages suggesting that abortion bans will block access to authentic medical care and treatments. Women in states that enact legislation protecting life, fearmongering pro-abortion voices shout, won’t be able to receive treatment for pregnancy complications that thousands face every year – from ectopic pregnancy to miscarriage. Recent news articles predict rising maternal mortality rates, describing a world in which doctors, hands tied by austere abortion restrictions, have no choice but to look away while their patients die of sepsis or hemorrhage...these narratives reflect, at best, a misunderstanding of the facts, and at worst, a deliberate distortion of the truth. In reality, a post-*Roe* world is much brighter for women and their children – it is one where the dignity of both their lives is respected and where they can receive real health care, not the band-aid of abortion.”

They note that “abortion is, in fact not necessary to treat pregnancy complications. According to the American College of Obstetricians and Gynecologists, an induced abortion is a procedure intended to terminate a pregnancy so that it does not result in a live birth. In other words, the specific purpose of an induced abortion is to end the life of a preborn child. From a medical standpoint, this is never necessary. This fact is clear in the case of miscarriage management, which in no way involves ending a life, only the removal of an embryo or fetus who is already deceased.”

There are some conditions where a mother must be separated from her child to save the mother’s life. This is different from an abortion. In an ectopic pregnancy, the embryo implants outside of the uterus, which can result in life-threatening hemorrhage for the mother. Even Planned Parenthood used to state on their website that treating an ectopic pregnancy is not an abortion. (Planned Parenthood recently removed this wording so that it wasn’t “twisted or mis-represented by anti-abortion politicians.”) Chorioamnionitis, which is an infection of the fetal membranes, can result in sepsis. This also requires the child to be separated from the mother by a premature delivery. The intent is to save the mother’s life, while trying, whenever possible, to save the child’s life as well. The child and mother are both treated with dignity and respect.

None of the conditional laws that have gone into effect since the *Dobbs* decision prevent doctors from

caring for women in these emergencies. The methods and tools may be the same, but the intent is completely different. The laws clearly state that lifesaving treatment, including for ectopic pregnancies, is not part of the definition of abortion. If the law does not include a definition, it is pulled from “elsewhere in the state code.”

Pro-abortion activists are quick to point out that a 2019 Ohio bill required doctors to “reimplant” ectopic pregnancies in the uterus or they could be charged. The bill died in committee when experts stated that unfortunately, we currently don’t have the technology to do this.

Dr. Francis states that she “has never once had to perform an induced abortion to save a patient’s life. Neither have I ever been restricted in my ability to treat life-threatening conditions...I can equally serve both mothers and preborn children as my patients. Induced abortion has no place in this approach to care, because it deliberately ends the lives of our most vulnerable patients. Killing one’s patients isn’t health care.”

Catherine Glenn Foster notes, “I learn from doctors how lawmakers can support both mother and child from the earliest moments. We draft life-affirming laws based on the biological reality of human development and the ethical principle that no child ever needs to be intentionally killed.”

They conclude, “Some abortion activists are attempting to spark fear about what is actually a positive development in our society. They obscure the fact that reproductive health care can and will thrive without abortion. In a world where obstetricians serve their pregnant and preborn patients with equal care, we will see improvements in health care quality and maternal outcomes. It is telling that opponents of such a future must lie to stop Americans from embracing it.”

### Other news:

Salon, the pro-abortion news site, worries that more and more medical students are opting out of abortion training. Micaiah Bilger reported at LifeNews.com on 8/8/22 that “a number of medical schools do not train students to abort unborn babies, and others allow students to opt out of the training.” As more states limit or prohibit abortions, “fewer medical schools and hospitals are expected to train students to become abortionists.” Bilger said that some abortion activists and politicians are looking to recruit “or possibly force – more doctors to abort unborn babies.” Politicians are also looking to end conscience protections for medical workers.

Bilger also wrote on 8/5/22 that Texas, to support mothers and babies and reduce maternal mortality, recently passed legislation to expand Medicaid funds for six months after babies are born. Funding is currently capped at two months. The federal Centers for Medicare and Medicaid Services rejected Texas’ application without an explanation. The Texas bill prohibits funds to be used for abortions. The governor may challenge this decision in court. Bilger stated, “The Texas Maternal Mortality and Morbidity Review Committee recommended this expansion as a top priority to protect women’s lives.” In contrast, the Biden administration is looking for ways to use Medicaid funds to pay for women to travel for out-of-state abortions if they live in a pro-life state.



**The American Board of Obstetrics and Gynecology (ABOG)**

recently threatened to decertify physicians who provide "misinformation and disinformation about COVID-19, reproductive health care, abortion and other OBGYN practices that may harm the patients we serve or public health...Eligibility to gain or maintain ABOG certification may be lost if ABOG determines that [physicians] do not meet the standards that they have agreed to meet and that the public deserves and expects." Dr. Donna Harrison, OB-GYN and CEO of the American Association of Pro-Life OBGYNs stated, "The threat by the pro-abortion ABOG to cancel the board certification of tens of thousands of OBGYNs who educate their patients about the peer-reviewed, evidence-based facts concerning abortion is an unprecedented intrusion into the doctor-patient relationship." Three pro-life medical associations sent a letter to the ABOG noting the ABOG statement "seeks to intimidate...It is a naked attempt to prevent these diplomats from exercising their constitutionally protected rights." Dr Harrison said legal action will be taken if necessary.
