
Dear Defender of Life,



## NEW YORK STATE LEGISLATION

The 2005-2006 N.Y. State Legislative Session will begin on January 5<sup>th</sup>. The



#### Sample Message:

Dear Governor Pataki:

I am deeply concerned that the abortion rate in N.Y. State is higher than any other state and is nearly double that of the rest of the United States—see statistics in the November 2003 report issued by the Office of State Comptroller Alan Hevesi. Other states have lowered both their rate of pregnancy and their rate of abortion by restricting Medicaid funding of abortion, passing informed consent (women's "right to know") laws; and requiring parental notification or consent before a minor is given an abortion. For example, Michigan lowered the rate of abortion by 56% by passing such restrictions. N.Y. State's high rate of abortion is not surprising in view of the fact that our state has no restrictions on abortion nor on Medicaid funding of abortion. Moreover, in our state legislation requiring informed consent and parental notification (or consent) die in committee, and thus are not subjected to public debate.

Please exert leadership and use your position to protect the life and health of our children, our women and families by supporting restrictions on abortion and abortion funding. Numerous polls consistently indicate that in doing so you will be representing the wishes of the majority of your constituents. Leadership in this matter will help restore trust and confidence in our state government because it will indicate that the wishes of its citizens, rather than the agenda of special interest groups such as NARAL and Planned Parenthood are a priority. 

# HEALTH & SCIENCE REPORT "EARLY INDUCTION OF LABOR" OR "LIVE BIRTH ABORTION"?



A new twist in the abortion semantics game has recently come to light. It has been reported that some hospitals have tried to avoid pro-life picketers and the resultant public controversy by engaging in another form of abortion that they disguise under the term "early induction of labor." Most hospitals make sure that abortions are done prior to the 23<sup>rd</sup> week of gestation, which is the most recent viability cutoff date of the American Heart Association and the American Academy of Pediatrics. Viability is the measurement used to determine when an unborn child can live outside the womb. But we all know that these children will not survive without intense medical care. In contrast, these hospitals and doctors wait until after the 23rd to 26th week. The mother is deliberately put into premature labor. The child is delivered and left to die. As Bradley Mattes states in the October 2004 Life Issues Connector, "In reality, it's a cold, calculated scheme to blur the line between spontaneous premature delivery and abortion. And it's become widespread."

Sadly, we must report that two Catholic-affiliated hospital systems, Loyola University Health System (Chicago) and Providence Health System (West Coast and Alaska) engage in this practice. Other health care systems spokespersons were either vague about the practice or did not return calls regarding the practice. Loyola and Providence state that they are acting within the guidelines of the 2001 US Bishops Ethical and Religious Directive for Catholic Health Care Services which states "For proportionate reason, labor may be induced after the fetus is viable." Theologian James LaGrye said the term 'proportionate' is used "for situations in which some grave risk would be incurred if an action were not taken to avoid it" [the mental health of the mother "is a reason to perform early induction." Father Jack O'Callahan, staff ethicist at Loyola, stated [they are trying] "to ward off the physical complications of bringing to term a child who is not going to live anyway." Mattes stated that Loyola defended itself by saying that "they only kill babies who are the victims of anencephaly or Potter's disease (underdevelopment of the brain and kidneys)." Mattes continues by stating that Loyola's defense "further them for discriminating condemns against handicapped newborns. The fact that they kill only a small segment of society doesn't make the dirty deed

any less vile. The Born Alive Infants Protection Act states that children who are lucky enough to survive an abortion will be afforded proper medical care to sustain their lives." Hospitals that perform live birth abortions may put their federal funding at risk. It is also possible that the Americans With Disabilities Act may be used to prosecute these institutions.

Jill Stanek, a registered nurse, states in an article on www.worldnetdaily.com (9/15/04), "Euthanizing one's handicapped child is not the solution to maintaining mental health, nor do handicapped babies normally spread voodoo vibes to make their mothers What about the physical and mental complications of abortion?" Stanek testified before Congress regarding live birth abortions. Reports have been sent to her from nurses all over the country confirming that live birth abortions continue to be performed. Jill states that as a nurse she is "ashamed of the medical profession. I shouldn't have to remind so-called Christian hospital administrators, ethicists and theologians that they are called to protect - not destroy - the most vulnerable and sickest among us. They are called to help parents bear the unbearable loss of a child, not trigger it."

The United States Conference of Catholic Bishops provided Jill Stanek with the following statement, "Early induction of labor before term (37 weeks) to relieve emotional distress hastens the death of the child as a means of achieving this presumed good effect and unjustifiably deprives the child of the good of gestation...Induction of labor before term performed simply for the reason that the child has a lethal anomaly is direct abortion." (LifeSiteNews, 10/4/04)

In direct contrast to the above, I refer you to the June 2004 Health and Science article regarding Grace Anne Nugent's story. Christine & Paul Nugent were urged to abort their child, who was diagnosed with Trisomy 18. Even if the child survived to term, she would be severely handicapped and would probably only survive a few days. The Nugents refused to abort their child, and instead, with the help of various agencies and individuals, welcomed Grace Anne into the world and were blessed to care for her for two months. There are wonderful resources on the website (www.graceannenugent.netfirms.com). Hospice and Support is a much more compassionate, loving and ethical answer for parents who are faced with a serious, life-threatening diagnosis for their unborn child.

#### KINGS PARK DROPS OUT OF TEEN CONFERENCE BY PLANNED PARENTHOOD

The above headline appeared in the October 7, 2004 edition of the <u>Smithtown News</u> on page 8. The article written by David Ambro begins:

"Under pressure from residents, the Kings Park School District will no longer officially participate in the Teen Health Conference hosted by Planned Parenthood.

Although making it clear that the Kings Park School District is a public educational institution open to all viewpoints, Kings Park School District Superintendent Mary DeRose announced Tuesday, October 5, 2004 that the district will no longer bring students to the conference. She said the district will provide parents with information about the conference, and they can bring their children themselves."

Who are these residents who pressured the Kings Park School District not to participate in the conference? Mr. Ambro continues:

"Dr. DeRose said that two local women came to the school board earlier in the year and urged that the district promote abstinence and drop out of the Planned Parenthood conference."

One of these women, Johanna Cervellino with her husband Lawrence has been active for years combating the lies promulgated by Planned Parenthood. Another resident of Kings Park, who may have had an impact on Dr. DeRose and the school board, is the Reverend Joseph V. Davanzo. Father Davanzo is the Associate Pastor of St. Joseph's R.C. Church in Kings Park. His letter to the editor of the Smithtown News was printed on 9/30/2004. In his letter he makes a case against Planned Parenthood.

## Death risk...

**Editor, The NEWS:** 

Women received important information in Phyllis Lader's column (9/23/04), where she warned that even cosmetic surgery carries the risk of death.

Hopefully the women students of Kings Park High School receive similar warnings of possible death when they are introduced to the products and services available through Planned Parenthood. (This introduction comes via the high school's annual sending of students to Planned Parenthood's Teen Health Conference. See Ms. Lader's article 6/17/04.)

Through Planned Parenthood, students can learn about oral contraceptives, such as the "sex patch," which delivers contraceptive hormones into the blood stream via the skin. However on Sept. 19th, the NY Post reported that since its release in 2002, the patch was responsible for 17 deaths in women ages 17 to 30. The Post also obtained records from the FDA which

also revealed 21 other "life-threatening" conditions from the patch, such as blood clots, strokes, and heart attacks. Yet on a Planned Parenthood web page (updated June 2004,) death is not list among the risks. Are our women students informed?

Also through exposure to Planned Parenthood, students can learn about the RU-486 abortion pill. In September 2003, PlanNed Parenthood gave this pill to an 18 year old woman in California, and she died after a very painful four-day ordeal. The Associate Press reported "a massive infection caused by fragments of the fetus left inside her uterus" caused "bleeding and cramps so severe that she was unable to walk," and her death was brought about by septic shock.

Since RU-486 received U.S. approval, its distributor has reported 400 complications to the FDA. These include one woman who died from an ectopic pregnancy, another who suffered a heart attack, and two 15-year olds who contracted life-threatening infections. A Canadian woman also died from a bacterial infection. Yet on a Planned Parenthood web page (current as of January 2004,) all of these risks are not listed. Are our women students informed?

Also, on their "Teenwire" website, Planned Parenthood describes abortion as a "very safe procedure." Tell this to the family of a 15 year-old girl in a Detroit suburb who died in January as a result of a second trimester abortion. The local Fox station reported that the doctor who performed the autopsy said the girl's death was caused by "uterine infarction with sepsis." The doctor also ruled the death as "normal," and explained, "these complication are expected with this type of abortion."

Women need to be informed of all the risks, especially the deadly ones, before they make any decision that changes their bodies. Will the Kings Park H.S. students, who receive or are exposed to information at the Planned Parenthood Teen Health Conference, be able to make a fully-informed choice, based on the whole and sometimes a deadly truth?

Or will Planned Parenthood, which prides itself on "choice," hide comfortably and guiltlessly behind NYS law, and let our students fend for themselves, because that law requires no parental consent or involvement whatsoever, when it comes to underage girls obtaining either abortion or abortion-related drugs and products?






