

## Pope John Paul II 1920-2005

He came to us from the very center of the 20<sup>th</sup> century's culture of death, having witnessed first hand – first under the Nazis, then the Communists – the destruction of human life on a scale unprecedented in all of human history.

And so Pope John Paul II brought to the Papacy an

unwavering commitment to the sanctity and dignity of every human life. "The Church defends the right to life," he proclaimed on the mall in Washington, D.C. in 1979 – to the thunderous applause of more than a million Mass goers, and the stony silence of the Supreme Court justices of Roe v. Wade infamy who were in attendance. He defended every unborn child as "a unique and unrepeatable gift of God." He called us to build a culture of life, responding in life affirming ways to the needs of the sick, the disabled, the poor and marginalized; and rejecting the abortion mentality's "destroy the victim" approach to human suffering. He taught us, through his words and through the powerful witness of his own suffering and death, that God gives meaning and purpose to every human life, at every stage of existence, regardless of condition.

"Maybe," he told the Bishops of Germany in 1999, "God has entrusted me the Chair of Peter at the threshold of the third millennium to be an impassioned advocate of life." That he was. We thank God for his leadership, and we pledge ourselves to continue the work of Pope John Paul II in proclaiming the Gospel of the Life.

## Beware the Planned Parenthood Organization

#### What's Planned Parenthood Planning Next?

Gloria Feldt, President of Planned Parenthood since 1997 recently announced her resignation. When Feldt became president, abortion procedures became more important in the organization's business bringing in an estimated \$49.8 million and accounting for 27.6% of its clinic income. Last year, Planned Parenthood increased the number of surgical abortions at its own facilities by 6.1% to 244,628. As a result the abortion income rose to an estimated \$104 million and accounted for 36.1% of its clinic income.

In 2004, Planned Parenthood aborted 138 children for every adoption referral to an outside agency. During Gloria Feldt's first full year as president of PPFA (1997), the group's abortion/adoption ratio was eighteen to one. Under Feldt, abortions have consistently increased and adoption referrals have decreased.

Even after 18-year old Holly Patterson was killed by complications from an RU-486 abortion at Planned Parenthood, the organization sold the dangerous abortion pill over 95,000 times at 203 of its clinics, including 49 that began selling the pill last year through they do not do surgical abortions.

In addition to increasing PPFA's abortions, Feldt has presided over a significant decline in Planned Parenthood's physical operations. When Feldt took over PPFA, it had 147 affiliates across the country that operated 938 clinics. Today it has 122 affiliates operating less than 850 clinics.

PPFA received a record \$265.2 million from government grants, about 33% of its \$810 million total income in 2004. However, private donations declined for the second time in three years, as contributions and bequests dropped 17% to \$191 million.

## China admits its girl shortage caused by one child policy is a "major threat"


Chinese government officials have admitted Monday that an enormous problem has been created by their long standing one-child policy. At this time, there are 117 boys for every 100 girls in china. There are 13 million more boys than girls under the age of nine.

The Chinese have traditionally favored boys over girls. A man can better care for his parents in their old age and he also carries on the family name. This custom has led to unapologetic female infanticide and the selective abortion of female children.

With a continuation of the current policy, by 2020, the gender discrepancy will be as high as 40 million more men than women. Officials are trying to curb female infanticide and selective abortion by outlawing ultrasonography for fetal sex determination and now impose fines for killing a child.

#### FAREWELL TERRI

#### U.N. ENDORSES ANTI-CLONING RESOLUTION

In a major triumph completely ignored by the media, the United Nations General Assembly on 3/9/05 voted 84-34 with 37 abstentions to accept a declaration calling all nations to pass laws prohibiting all forms of human cloning. This resolution applies to 191 member nations.

## UNBORN CHILD PAIN AWARENESS ACT S.51/H.R. 356.

## Action—Sample Message to your Senators and House Member:

I support the Child Pain Awareness Act S.51/H. R.356 and ask that you vote for this legislation.

The bill requires every abortionist to provide, whenever a woman seeks an abortion past 20 weeks and regardless of the abortion method used, specific information about the capacity of her unborn child to experience pain during the abortion. The woman may either accept or refuse the administration of pain reducing medication directly to the unborn child.

## NEW YORK STATE LEGISLATION



Lobbyists in Albany are continuing to wage a very intensive campaign promoting easy assess to the so-called "morning after" pill and bills providing financing of cloning/embryonic stem cell research. To counter the ongoing campaign of anti-life lobbyists hundreds of letters and calls are needed. CALL! WRITE! Urge others to call or write.

The UNINTENDED PREGNANCY ACT-A.116 passed the Assembly on 1/31/05. On 3/28 Senator Nick Spano introduced S.3661, a bill which matches A.116. S.3661 has been referred to the Higher Education Committee chaired by Senator Kenneth LaValle.

Action—Sample Message to Senator LaValle and your own Senator: Please oppose the "Unintended Pregnancy Act" S.3661 introduced by Senator Spano. Distribution of Emergency Contraception without a doctor's prescription exposes women, of any age, to mega-doses of potentially dangerous medication without a medical exam or physician oversight. Emergency Contraception can at times have an abortifacient effect, killing a newly formed human embryo by preventing implantation. Regions where Emergency Contraception is sold without a doctor's prescription have seen a large increase in the incidence of sexually transmitted diseases without decreases in unintended pregnancies. Protect our women and children by opposing S.3661/A.116.

HUMAN CLONING AND EMBRYONIC STEM CELL RESEARCH LEGISLATION-On 3/15/05 Senator Liz Krueger (D.NYC) proposed an amendment to the health care budget bill that would have funded embryonic stem cell research at the cost of \$1 billion. Senator Ruben Diaz (D-Bronx) spoke forcefully against the amendment on the Senate floor. The amendment failed with only 22 members voting for it. THANK YOU, SENATOR DIAZ!

## THE DOLORES ANDRESKI MEMORIAL MICHAEL FUND WALKATHON 2005

The International Foundation for Genetic Research is popularly known as The Michael Fund. This foundation opened it's doors in 1978, with world-renowned geneticist, Dr. Jerome Lejeune, as Medical Director and Randy Engel as Executive Director. The Michael Fund is the prolife alternative to the National Foundation/March of Dimes that was

in a decade long battle with the pro-life movement because of their funding of live fetal research that was inhumane and their search and destroy policy (amniocentesis) as the "cure" for birth defects.

A number of the March of Dimes (MOD) grantees have used aborted babies as a source of spare parts or fetal blood obtained by "openheart puncture of healthy ten week aborted fetuses. During the 1970's & 1980's it was MOD's private foundation monies that permitted these researchers...to bypass the government ban prohibiting the use of federal funds for such non-therapeutic, lethal experimentation on live human fetuses."

In 1979, the Long Island Coalition for Life looked for a way to fund this new, pro-life foundation. The annual (since 1980) walkathon was the result. Last year the walkathon's name was changed to honor the passing of one of God's most precious servants-Dolores Andreski. She dedicated her life to uphold the sanctity of all human life from conception through death. We ask you all to please consider joining us for our 26th walkathon between the opening ceremonies at noon until 3 pm. The path is 2 miles long and may be repeated as many times as you choose and have informed your sponsors. Contributions from those unable to participate in the walkathon are gratefully accepted. Your participation acknowledges that we are all members of the human family in which every human life is sacred and worthy of respect and support.

Studies have demonstrated that mental retardation, particularly that associated with chromosomal anomalies, often is amenable to treatment. The Michael Fund's Dr. Paddy Baggot's research has focused in on the time span in fetal development when retardation has not been observed and on early prenatal intervention treatment for these preborn children affected by chromosomal disorders.

Dr. Marie Peters Ney, Director of Medical Research, has worked with the International Center for Metabolic Testing on nutritional and chemical supplementation for children with Down Syndrome. She notes, "preliminary studies have documented a number of improvements in the health of children with Down Syndrome.... This study needs to be continued so that it be possible to evaluate neurological development."

Your contributions to the Michael Fund will help us fund life-giving research, genetic causes and treatments of Down Syndrome and related chromosomal disorders, genetic information agencies, support systems, physician referrals for specific birth anomalies,

Much has been done. Much remains to be accomplished. Help us honor Dolores and her years of tireless service to uphold the rights of the handicapped, born and preborn, and their families. ### QUESTIONS & ANSWERS

Question: Since the Terri Schiavo case illustrates the importance of appointing a health care agent and of preparing a written advanced directive, where can I obtain a document to accomplish both?

Answer: The "Will to Live" offered by The National Right to Life Committee, Inc. (NRLC) is a Pro-Life alternative to the Living Will and satisfies both objectives.

The NRLC has prepared a document called a "Will to Live" which people can use to appoint an agent and state their desire for food, water, and life-saving medical treatment if they become unable to speak for themselves. Separate forms have been prepared for each state to comply with state laws.
