

Dear Fellow Defender of Life,

I really believe we finally have the pro-aborts on the run. Hillary Clinton, John Kerry, and even Howard Dean, have been making conciliatory—though certainly deceptive—"middle ground on abortion" speeches. Locally, Nassau County Executive Tom Suozzi is headlined in *Newsday* as making a ". . push for abortion alternatives." In reading the article, however, one finds that Planned Parenthood of Nassau County is thrilled with Suozzi's proposals because it will mean more money for them.

Don't be fooled by the donning of sheep's clothing by these wolves. But do recognize that many politicians no longer feel they can safely let their pro-abortion militancy show in their speeches lest they suffer defeat by the "moral issues" voters (that's us!) at the polls. So they attempt to assume a "moderate" guise with respect to abortion. This is something that they have rarely felt the need to do in the past.

The public is waking up to the extremism of pro-abortion groups and the politicians they support. That awareness is showing up in opinion polls, in the voting booth and in public support for outfits like Planned Parenthood (PP). Planned Parenthood Federation of America has seen declining private donations for two of the last three years and has reduced its number of US clinics by 88 in the last seven years.

As the number one abortionist in the US—currently killing one-quarter million pre-born babies a year—PP clearly continues to be a major adversary. As you know from reading *Life News*, we have articles in nearly every issue describing the insidious activities of the PP organization and how to combat them. We also encourage peaceful vigils at their offices and confront them at public venues. The adjacent picture was taken on April 15th of this year and depicts several of the more than thirty prolife stalwarts protesting a PP sponsored seminar for high school educators at Stony Brook University



FEDERAL LEGISLATION

President Bush and Federal Judges

Article 11 Section 2 of the Constitution informs "The President with the advice and consent of the U.S. Senate shall...appoint Judges to the Supreme Court."

The nomination by the President had traditionally and historically merely called for the majority (51) of the Senators' approval. In 2003 this was changed by the Democrats, using the filibuster, to require 60 votes for approval. This makes it extremely difficult for a president to have his candidates approved. Senator Bill Frist (R. TN.) Senate Majority Leader intends to declare the 60 vote requirement out of order.

Action: Call Senators Hillary Clinton & Charles Schumer at 202-224-3121 or (toll free) at 877-762-8762.

Sample Message: Urge them to:

1. End the filibuster of judicial nominees.

2. Allow a stand up vote on the Senate floor.

3. Remind them that a 60 vote requirement for judges is unprecedented according to the Constitution.

DOWN'S SYNDROME, SPINA BIFIDA & OTHER CONDITIONS:

According to a report in the March edition of the American Journal of Obstetrics & Gynecology there is a need for legislation to provide scientifically sound information and support services to patients who receive positive (pre-natal) test diagnoses for Down's syndrome, Spina Bifida and other conditions. Expectant mothers, the study showed, often receive only negative information when a prenatal exam shows a possibility the baby has Down's syndrome and are seldom counseled with the latest information or referred to parent support groups during the decision time. A 1990 study revealed that 88% of 22,000 women whose child had been diagnosed with Down's syndrome chose to abort the child. (Adapted from: Life Advocacy Briefing 4/18/2005)

HOUSE OK'S LIMITING OVER STATE LINE ABORTIONS

April 27, 2005 by a 270-157 vote, the House approved a bill, the Child Interstate Abortion Notification Act (CIANA), that would make it illegal to transport a minor over a state line for the purpose of obtaining an abortion. Senator Bill Frist has promised to bring a comparable bill up for a Senate vote by this summer. One aim of the bill is to prevent sexual predators from evading prosecution in a state where abortions on minors are prohibited without parental consent.

Action: Call Senators Clinton & Schumer.

NEW YORK STATE LEGISLATION



Family Protection Act S. 2139/A.4753

(introduced by Senator Padavan and Assemblyman Barra). Nassau/Suffolk sponsors are Senators Flanagan, Johnson and Trunzo and Assembly members Alfano, Barra, Conte, Fitzpatrick, O'Connell, Raia and Saladino.

Action: Contact your Senator and Assembly Member asking they actively support this bill. Thank those who are sponsors.

Sample Message: Please support the Family Protection Act S.2139/A.4753. This pro-life, pro-family bill offers an opportunity for all legislators, whether or not they consider themselves pro-life, to work together to protect the health and safety of young women who could be our daughters or granddaughters.

Do you believe women have a right to all the relevant facts that might affect their health and safety before consenting to the abortion procedure? Despite the many research studies which indicate evidence of serious and long-lasting physical and psychological damage done to women by abortion current state law does not require that the woman receive information about the harm abortion can do. The Family Protection Act would require that a woman considering an abortion be given information regarding the development of her baby, the effects of abortion on a woman's physical and mental health and the alternatives to abortion.

Do you believe that girls under 18 should be given an abortion without parental knowledge or consent? Under current state law girls as young as twelve or thirteen can be given an abortion without parental knowledge. Having no parental consent law makes it easy for an older man to take advantage of a young girl, coercing her to have an abortion to avoid parental responsibilities and other consequences to himself. (A study by Life Dynamics, Inc. found that among girls 15 and under who become pregnant, between 60 and 80% are impregnated by adult males and according to the same study 90% of abortion providers fail to report this crime of statutory rape.) The Family Protection Act would require parental consent for girls under 18 years of age or alternatively a court waiver.

Protect our women and our families by working for the passage of the Family Protection Act. Please reply.

HEALTH & SCIENCE REPORT THE HISTORY OF THE OVERPOPULATION MYTH AND EUGENICS



(Editor's note: in the first two parts we saw the origins of the eugenics movement and the rise of Margaret Sanger.)

PART III: THE BIRTH OF PLANNED PARENTHOOD

Sanger's "Plan for Peace" appeared in her Birth Control Review in April 1932. It stated, "The first step would thus be to control the intake and output of morons, mental defectives, epileptics. The second step would be to take an inventory of the secondary group such as the illiterates, paupers, unemployables, criminals, prostitutes, dope fiends; classify them in special departments under government medical protection, and segregate them on farms and open spaces as long as necessary for the strengthening of moral conduct. With the future citizen safeguarded from hereditary taints, with 5 million mental and moral degenerates segregated, with 10 million women and 10 million children receiving adequate care [likely forced abortion or at least enforced use of birth control] we could then turn our attention to the basic needs for international peace." Jalsevac states that "Sanger was repulsed by the poor working 'race', which she thought had been created by the Industrial Revolution. She saw them as even worse than what she considered the sub-human Negro. Her "Code to Stop Overpopulation of Children" included, "A marriage license shall in itself give husband and wife only the right to a common household and not the right to parenthood...No woman shall have the legal right to bear a child, no man shall have the right to become a father, without a permit for parenthood...Permits for parenthood shall be issued to married couples upon application, providing the parents are financially able to support the expected child, have the qualifications needed for proper rearing of the child [which qualifications, presumably, would be decided by eugenicists' criteria, as happened later in Germany]...Feeble-minded persons, habitual congenital criminals, those afflicted with inheritable diseases, and others found biologically unfit [i.e., Jews] should be sterilized in cases of doubt and should be isolated [i.e., concentration camps] so as to prevent the perpetuation of their afflictions by breeding."

Jalsevac states, "At her 1925 International...birth control conference in NY, she...engineered a loose federation of 'race hygiene societies', 'birth control leagues', 'family planning associations', and 'social eugenics committees' to make a more united and con-

certed eugenics effort. This federation laid the foundation for what would become International Planned Parenthood...She went after every grant, foundation, and philanthropic organization that existed. The money came pouring in from the likes of the Rockefellers, who founded the Birth Control League as early as 1925, the Fords, and the Mellons. By 1964, the Rockefeller and Ford Foundations would give Sanger's organizations over 100 million dollars. She established her first birth control clinics among the communities of the poor ethnic peoples of the supposed 'dysgenic races'. The Margaret Sanger Research Bureau also financed the development of the birth control pill, and Sanger financed and engineered the immigration into the US of Dr. Ernst Graefenburg, one of the pioneers of the IUD...She began to build a vast political machine to topple all resistance to her birth control and abortion policies." Planned Parenthood states on its website, "By the 40's, she had won the endorsement of... Eleanor Roosevelt and Katherine Hepburn. By the 50's, she had attained international renown and counted among her supporters... Einstein, Nehru, J.D. Rockefeller, Emperor Hirohito, and Henry Ford. Before her death she received enthusiastic endorsements of former Presidents Truman and Eisenhower."

Jalsevac reports that Truman and Eisenhower served as co-chairman of an Honorary Council for Planned Parenthood of America. Her "Negro" project in 1939 was one of her most successful programs. She stated "The most successful educational approach to the Negro is through a religious appeal. We do not want word to go out that we want to exterminate the Negro population and the Minister is the man who can straighten out the idea if it ever occurs to any of their rebellious members." Jalsevac explains, "Her campaign was a concerted effort to swindle African Americans into participating in their own extermination. Unfortunately, she met with much success. Birth control clinics began springing up in black communities all over the south, beginning a process that would continue until today. The long-term result of her work was that, by the 1980's, PP could take pride in the fact that 3 out of every 4 abortions in the US were black abortions - a trend that has continued into today."

The connection between the eugenics movement and the Nazi atrocities required some damage control on the part of Sanger. She changed the name of the Birth Control League to Planned Parenthood (PP) in 1942.

In the next part we will see how Planned Parenthood grew in influence and power with the help of U.S. governmental and international agencies and many rich and powerful Americans.


