Dear Defender of Life.

Wow! It's been a very busy year for your Long Island Coalition for Life. Our public witness events (see article on page 8) reached new peaks this year culminating with 40 Days for Life. For the first time ever we had dual Stand Up for Life events, one in Huntington and the other in Manorville. We were particularly pleased that the first-time Stand up For Life, East, had over one-hundred participants. The picture here shows part of that contingent.



This was also the first year of our venturing into the realm of Public Access TV. We produced four different hour-long programs combining videos from several sources. Topics included stem cell research and cloning, physical and psychological effects of abortion, ultrasound imaging of babies in the womb, and poignant testimonies of women regarding their regrets about their abortions or their joy at making the choice for life. These programs continue to be seen on cable channel 20 in most areas of Long Island on Tuesday evenings. Also on TV this fall, our Educational Trust, in cooperation with Vitae Caring Foundation, again ran pro-life ads on cable channels during prime time each night in the largest cable markets in Nassau and Suffolk counties, reaching over 400,000 households.

Looking toward next year, our intrepid Albany lobbying team is gearing up for their first trip of the 2008 legislative session on January 9th. Lobbying in 2008 will be particularly important as Gov. Spitzer has plans to pass his extreme "Reproductive Health and Privacy Protection Act" (RHAPP) which would, among other things, ensure that abortions are legal throughout all nine months of pregnancy, allow post-viability abortions to be performed on an out-patient basis in clinics, allow non-physicians to perform abortions, and could eliminate conscience protection of religious hospitals which refuse to perform abortions. We have already obtained hundreds of signatures on our petitions opposing RHAPP. By the time of our January trip we hope to have thousands to present to our elected officials in Albany. Please contact us for petitions to sign.

As you can see, our work of protecting innocent human life at all stages goes on without letup. For that we give thanks to the unstinting dedication of many volunteers and the reliable support of our generous contributors. And recently Fr. Frank Pavone, National Director of Priests for Life, enumerated **ten reasons why we're winning the battle** to restore protection to children in the womb. But, he cautioned, ". . . the closer we get to victory, the harder the other side will push back. This should not, therefore, be interpreted as an invitation to relax our efforts. . .but rather to intensify our efforts and to recruit more people to join a winning team." Please be part of the winning team on Long Island by helping your Long Island Coalition for Life with a yearend gift so we can continue to intensify **our** life-affirming efforts in 2008.

Your prayers are also vital for ultimate success in protecting innocent human life. Please keep them up and God bless you for all you do to affirm life.

### IS ROE v WADE IN THE CONSTITUTION? by Dr. Willke

During hearings in June before the Ohio House Health Committee on the HB 228 Abortion Ban bill, misconceptions concerning *Roe v Wade* and the U.S. Constitution were presented as fact by pro-abortion and even some "pro-life" supporters and legislators. Here Dr. Wilke clarifies what is truly the case on this matter.

The original Constitution of the United States and its subsequent amendments do not in any way, shape, or form mention abortion. Therefore, since it does not mention abortion, the regulation of permission or forbidding of abortion falls under the Tenth Amendment, which stated, "The powers not delegated to the U.S. Government by the Constitution nor prohibited by it to the states are reserved to the states respectively or to the people." This means that the regulation of abortion in the Constitution and in its Amendments was not to be done by the federal government, but rather reserved to the states.

The original colonies operated under British Common Law and so did the original states until each of them, one by one in the 1800's, passed their own laws about abortion. Both English Common Law and the later state laws all forbad abortion, all protected from conception, all had exceptions for the life of the mother. A few had other exceptions, like rape and incest.

In 1965, in *Griswold v. Connecticut*, the US Supreme Court ruled that the "right to privacy" existed in the U.S. Constitution. They ruled that this protected married couple's private use of birth control. This was the first decision that had ever mentioned such a right. This new "right" in the area of human reproduction led the way to abortion.

On January 22, 1973, the US Supreme Court handed down not one, but two decisions on abortion. Most people know about *Roe v Wade*. Many are less familiar with the second decision, *Doe v Bolton*. It is the total of the two that gave us the impact on this issue. The first decision, *Roe v Wade*, divided pregnancy into three trimesters, permitting abortion on demand in the first, abortion with some restrictions in the second and substantial restrictions in the third. Basically it said that a state is forbidden to forbid abortion if in the opinion of "one licensed physician," an abortion is necessary to preserve the "life or health" of the mother. The court also said that it could not determine when human life began but did admit that if it was shown that human life did begin at fertilization that "our entire case collapses."

Most of the impact of the decisions flowed from their definition, not of the life of the mother, which all states had in their earlier laws, but rather of "health." What then did health include?

Roe v Wade included when a pregnancy would "force upon a women a stressful life and future.... produce

psychological harm....tax mental and physical health by childcare....bring the distress associated with the unwanted child....bring a child into a family already unable psychologically or otherwise to care for it....bring the continuing difficulties and stigma of unwed motherhood."

Doe v Bolton added the real stinger. It said that the word "health" means that "the medical judgment may be exercised in the light of all factors, physical, emotional, psychological, familial and the woman's age—relevant to the well-being of the patient. All these factors may relate to health."

In effect, the above statements in the two decisions completely neutralize any impression given that there were any restrictions on the right to abort. To make this perfectly clear, the United States Senate, June 7, 1983, in a Senate Joint Resolution concluded the following, "thus the Judiciary Committee observes that no significant legal barrier of any kind whatsoever exist today in the United States for a woman to obtain an abortion for any reason during any stage of her pregnancy".

It is true that some states still have restrictive laws on their books [Ohio does not—ed.], but these are nonfunctional. Under the jurisdiction of the U.S. Supreme Court decisions above, it is quite clear that what the court decided was absolute abortion on demand for the full nine months of pregnancy for any reason whatsoever. The only requirements have been that the woman requests it and that a licensed physician do the job. And all she needs to find an abortionist is money.

So this is the state of affairs in the United States today. One statement that is frequently made is that these decisions are "part of the Constitution." This is a complete

misunderstanding and is not true. These decisions are binding because a Supreme Court ruled them, but they are not part of the Constitution. There are over 200 decisions by the U. S. Supreme Court in the history of the U.S. that have been overturned at some later date, the most obvious one has been slavery, another, school segregation. In fact then these abortion decisions can be completely undone by another decision of the Supreme Court.

### **HEALTH & SCIENCE** "MICRO-EUGENICS" Part II

(continued from Nov.2007 Life News)

The final article in the Newsday series is titled "Potential for Abuse". Whitehouse writes, "PGD (preimplantation genetic diagnosis) could allow scientists to screen out diseases that run in a family...One bioethicist has coined a term for choosing the 'best' embryo - procreative beneficence- suggesting that if a couple has the ability to produce the healthiest child, they have a moral obligation to do so." David Adamson, reproductive endocrinologist and president-elect of the American Society for Reproductive Medicine stated, "This... technology...is going to determine how we recreate ourselves."

PGD was originally designed to identify "lifethreatening hereditary childhood diseases." It is now being used to identify diseases that may appear at a later stage, such as breast cancer. It is also being used to identify nonfatal afflictions. Mark Hughes of the Genesis Genetics Institute is "comfortable with families trying to eliminate such diseases from their descendants."

Whitehouse states that some doctors fear that one day non-medical traits may be screened for, such as eye color or musical ability. "The science may move from guaranteeing a healthy baby free of certain diseases to customizing a child." Thomas Murray, president of The Hastings Center asks, "Will parents try to do that? Really select a child's characteristics the way you can pick a car? Not many. But it doesn't take many to make it an issue." The article states that Stanford physician and bioethicist William Hurlbut remarked that "parents could end up engaging in 'micro-eugenics'. Rather than a state-imposed program of eugenics, it would be the parents themselves who could one by one weed out genes they consider undesirable." Ethicist Adrienne Asch at Yeshiva University in New York said, "Parents should see children as worthwhile however they are, not as embryos to be selected into perfection... people should be prepared to be parents of any child that could be born."

There is also the concern that insurance companies might eventually require testing, and deny health or life insurance to those children identified with certain diseases. Currently, PGD is not regulated in the US.

Whitehouse acknowledges that PGD is already being used for non-medical reasons, especially for gender selection. She uses China as an example. Within 15 years, there will be 30 million more men of marrying age than women because of China's one-child policy, and the "cultural preference for a male child is so strong there, some women abort their baby if a sonogram shows it is female."

Francis Fukuyama, professor at Johns Hopkins School of Advanced International Studies, stated, "We need a mechanism for determining the moral acceptability of new biomedical technologies that really reflects an informed, democratic discussion.. What it's going to take is some accident or some cloning experiment that goes wrong for people to sit up and say, 'My God, I didn't know we could do these kinds of things.""

Sean Tipton of the American Society for Reproductive Medicine said, "Americans tend not to want to have government making the decision about who gets to have kids and how and why." Eric Parens of the Hastings Center "worries about 'genetic privilege'. It strikes me as implausible that we're going to get from today, where 47 million people in the US are without health care, to a world where everybody has access to PGD. There's no doubt in my mind that in 100 years, people who are already privileged will have the privilege of using technologies like PGD." Whitehouse states that Parens supports some type of regulatory body to determine "what is acceptable to do to an embryo and what is not. But few politicians would want to tackle it." Parens stated, "we don't have an opportunity to have an open and clear debate about the difference between what we take to be reasonable things to do with embryos and what we take to be unreasonable things to do to embryos."


Whitehouse also cited the concern some scientists have for the aggressive marketing of PGD. Marcy Darnovsky of the Center for Genetics and Society stated, "It's uncomfortable to think of anything related to a child and reproduction as an industry, but it has become a multibillion dollar technology. Half jokingly, she said doctors may begin to advertise with slogans like: 'We give you an 82% chance of scoring 100 points higher on your SATs.' The dangers are that under the pressure of marketing, parents will feel we have to do it to give our kids the best start in life. Then you set up this vicious cycle where people are seeking the perfect child. We lose a lot of what it means to be human in that and head toward a world of genetic castes."

David Adamson said, "Everything in life is a cost benefit analysis...Let's weed out the bad as we come to it. We're not going to stop the future, and we're not going to stop the technology."

The sad part in all of this is that most of these scientists and doctors have lost sight of the fact that every embryo is a human being - one that needs to be respected and treated with the utmost care. Technology has turned the embryo into a commodity, something that can be manipulated, experimented upon or discarded at will. As geneticist Dr. Jerome Lejeune once said, "Not everything that can be done should be done." Are we going to eradicate disease by finding a cure, or by eventually eliminating every child conceived with a disease? How many children will be created and destroyed during this process? We must pray for science to find a cure for every deadly disease, using ethical research standards, so that parents will not be faced with such a heart-breaking decision. 




### Pro-Life Education: Taking it to the Streets




