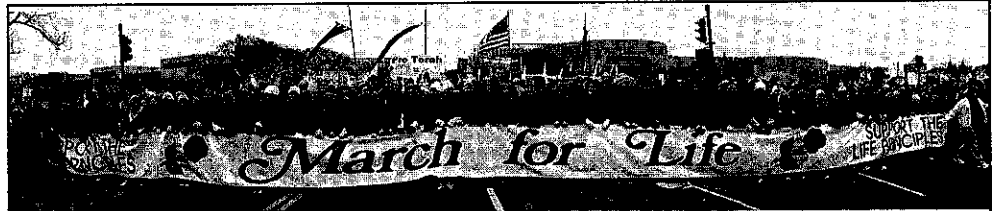

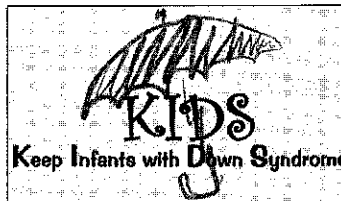

The Manhattan Declaration

"**The Manhattan Declaration: A Call of Christian Conscience**" was released last month by evangelical, Orthodox and Catholic leaders who came together to stand firm on what they consider the three most foundational issues in society – the sanctity of life, the sanctity of marriage between one woman and one man, and religious liberty. It is called "The Manhattan Declaration" because the first draft was presented in Manhattan in September 2009. This is a non-denominational, non-partisan Declaration.

The lives of the unborn, the disabled and the elderly are ever more threatened. Polls show that public opinion has moved toward a pro-life direction, however there are powerful forces working to expand abortion, embryonic stem cell research, assisted suicide, and euthanasia. While the government's first obligation is to protect the weak and vulnerable, it instead promotes

a "culture of death." The signers of this Declaration pledge to work unceasingly for the equal protection of every innocent human being at every stage of development and in all conditions. This is non-negotiable.

The Declaration states, "*We are Christians who have joined together across historic lines of ecclesial differences to affirm our right—and, more importantly, to embrace our obligation—to speak and act in defence of these truths. We pledge to each other, and to our fellow believers, that no power on earth, be it cultural or political, will intimidate us into silence or acquiescence.*"

FEDERAL LEGISLATION

HEALTH CARE REFORM must be monitored daily, via the web, TV, and print media, until finalized. It is imperative representatives, including those who vote pro-abortion, are contacted by their pro-life constituents. Be assured that pro-abortion advocates, many of whom will benefit financially from abortion and anti-life research funding, contact their representatives continuously.

NRLC website, 12/7/09: "There is widespread public opposition to using federal funds to subsidize abortions, thus the need for pro-abortion congressional leaders and pro-abortion President Barack Obama to deny that this is precisely what they are doing."

At this writing, 12/7/09, we note (as an example of what is included in pro-abortion bills and amendments), on 12/5/09, the Senate passed a bill authorizing the Health Resources and Services Administration to include abortion as "preventative care" in their guidelines. If HRSA decides to include abortion in its guidelines, then all group and individual health plans will be required by law to cover abortion.

There is no current federal law that would prevent the new programs created by the pending health care bills from paying for abortions on demand and the White House knows this too well. **Only language written directly into the bill would prevent government funding of abortion.**

ACTION-SAMPLE MESSAGE:

Dear ___: You are urged to oppose any health care reform unless abortion, euthanasia and funding of technologies that destroy human life are explicitly excluded. The language of this legislation must be specific and terms such as "medical procedure," "clinical practices," and "preventative care" must be defined and eliminated if these would allow abortion. In addition, "Conscience Protection" for health care providing institutions and workers must be included in the bill.

NATIONAL INSTITUTES OF HEALTH AUTHORIZES 13 LINES OF CELLS

Yesterday, the Obama administration approved the first human embryonic stem cells for experiments by federally funded scientists. All were obtained from embryos left over by couples seeking treatment for infertility. Extracting the cells destroys days-old embryos.

The announcement was condemned by opponents of the research who argued that aside from being unethical the work is unnecessary because of the availability of adult stem cells and other more recently identified alternatives.

EMBRYONIC STEM CELL RESEARCH

IN NYS—New York has become **the first and only state that will pay women for their eggs.**

Compensation was approved by the Empire State Stem Cell Board (ESSCB) Funding Committee of the New York Stem Cell Science (NYSTEM) on 6/11/2009. The ESSCB oversees \$600 million of NY taxpayer funds for stem cell research allocated over 10 years beginning 4/2007.

New Presidential Commission for the Study of Bioethical Issues, New Human Embryonic Stem Cell Lines for Research



This past June, President Obama disbanded the President's Council for Bioethics with one day's notice. The charter was scheduled to expire in September. Steven Ertelt of *LifeNews.com* reported there "was some thought it was booted early to clear the deck for a new bioethics group aligned with the president." (*Lifenews.com*, 1 Dec 2009) Dr. David Prentice, a fellow at the Family Research Council, stated, "Seems likely the old bioethics council was just giving contrary signals to the president (10 of the 18 members criticized the president after his March 9 speech where he opened the possibility of using more human embryos for research, including creating cloned human embryos for experiments."

James Tillman reported on *LifeSiteNews.com* (2 December 2009) that "According to the *New York Times*, the [previous] council was seen as 'a philosophically leaning advisor group' favoring discussion over developing consensus; and President Obama instead desired a commission offering 'practical policy options'... The major difference between the two groups can be seen in the executive orders establishing them. In the executive order establishing the previous council, President Bush commanded it to 'strive to develop a deep and comprehensive understanding of the issues that it considers. In pursuit of this goal, the Council shall be guided by the need to articulate fully the complex and often competing moral positions on any given issue, rather than by an overriding concern to find consensus.'" Tillman continued, "Such a directive resulted in the council producing documents that have been praised as being of 'high literary and philosophical quality... on the other hand [Obama's commission] calls upon it to serve more as a political body and to 'recommend any legal, regulatory, or policy actions it deems appropriate to address [bioethical] issues.'"

Tillman further reported that Obama's order "mandates one to three members of the thirteen-member commission to be members of the executive branch of the government. Members of the previous council had been explicitly prohibited from being 'offices of the federal government.' President Obama also announced that Dr. Amy Gutmann, president of the University of Pennsylvania, would be the chair of the commission and Dr. James W. Wagner, president of Emory University, would be the vice-chair. In keeping with the policy-oriented nature of the commission, neither Gutmann nor Wagner are bioethicists. Gutmann is a professor of

political science and Wagner has his doctoral degree in materials science and engineering." According to Tillman, Dr. Gutmann has written about ethical issues outside of bioethics. "Her views on how government policy ought to be affected by the moral values of citizens can be found in the essay 'Undemocratic Education.' In that essay she discusses a court case in which parents wanted their children to be exempt from reading a text in school that the parents said contradicted their religious beliefs. 'The parents claimed that their children would be corrupted by exposure to beliefs and values that contradict their own religious views without a statement that the other views are incorrect and that their views are the correct ones... Democratic education is surely incompatible with this fundamentalist view of knowledge and morality... [it is] a serious misunderstanding [to say that] a policy is repressive simply because it prevents parents from teaching their sincerely held beliefs or requires the teaching of views inimical to, or undermining of, those beliefs within publicly funded or subsidized schools.'"

James Tillman reported at *LifeSiteNews.com* on December 2nd that the U.S. National Institute of Health (NIH) approved the first new 13 human embryonic stem cell (hESC) lines for use in NIH-funded research. "The approval is the result of an executive order issued last March, when President Obama overturned President Bush's ban on the use of new hESC lines in federally-funded research. Dr. Francis Collins, director of the NIH, announced, "In accordance with the guidelines, these stem cell lines were derived from embryos that were donated under ethically sound informed consent processes." Tillman explained, "The actual destruction of embryos and the creation of hESC lines is still performed with private money; taxpayer funding is for the research conducted with these lines... More than 20 additional stem cell lines may be approved on Friday; 96 lines are currently submitted to the NIH for consideration. Over \$20 million in over 30 NIH grants pertaining to ESC research had been restricted from use before this announcement."

The order establishing the new bioethics council does not name the other members of the commission. Dr. David Prentice stated that the order "could allow Obama to stack the panel in favor of his pro-ESCR view... so there is a chance to seed the commission with like-minded folks... It will be interesting to see the final composition of this new presidential bioethics group, and whether they can live up to the openness, education of the public, and representation of diverse views seen with the last bioethics council. If not, it will just be a rubber stamp for presidential policies." Ertelt concluded by stating, "Time will tell whether Obama's bioethics council will give him the political cover and apparent scientific support he needs to move from ESC research to human cloning."

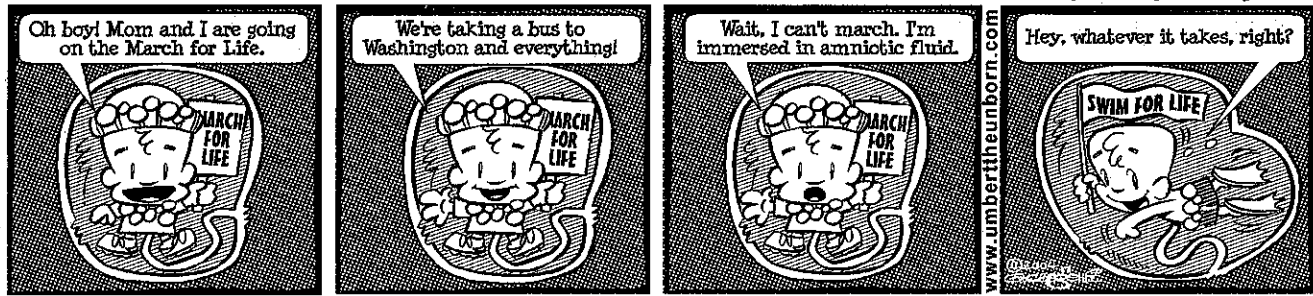
