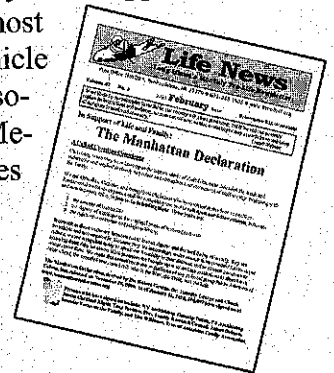

Dear Fellow Defender of Life,

I am writing this having just returned from an eight week sojourn in Manhattan, five weeks as an inpatient at Memorial Sloan-Kettering Cancer Center and three weeks receiving twice weekly outpatient treatment there. The objective of all of this was to accomplish a stem cell transplant—from an adult donor—to try to cure my lymphoma which had previously responded to chemotherapy but had recurred. I have done very well so far and I attribute that to all the prayers which so many have offered on my behalf and for which I am profoundly grateful. Thank you for those prayers, your well wishes and the many cards you sent during my stay in Manhattan. Please continue to keep me in your prayers as my recuperative period will extend for several months as my new immune system gradually takes over, hopefully destroying any residual cancer cells as it does so.

FEDERAL LEGISLATION

CHALLENGES TO OBAMACARE (the popular name for the "Patient Protection and Affordable Care Act" passed by Congress and signed by President Obama in March of 2010.) Challenges have begun, on a variety of fronts. As of

early May, State Attorneys General from Alabama, Colorado, Florida, Idaho, Indiana, Louisiana, Michigan, Nebraska, Nevada, Pennsylvania, South Carolina, South Dakota, Texas, Utah, Virginia, and Washington have filed law suits, but some experts say that under the 6th Amendment, these will fail. Others have suggested Federal Court challenges under Bill of Rights Amendments #4, 5, 7, 8, 9 and 10.

RESPONSE TO OBAMACARE - Rep. J. Pitts (R-PA) has filed the Protect Life Act (HR 5111) in the House, designed to prevent government funding of abortion through the Office of Personnel Management, community health centers, government exchanges, or any program authorized in the ObamaCare bill. Major Pro-life groups have yet to announce their view of HR 5111. Please check for updates. No one from Long Island has co-sponsored as of 5/7/10.

ACTION-SAMPLE MESSAGE (to House Reps): Please co-sponsor the Pitts Protect Life Act, HR 5111. It applies Hyde Amendment language to the ObamaCare bill, and adds conscience protection for health workers and private insurers.

NEW YORK STATE LEGISLATION

The 2010 Session will recess approx. July 1. Until then **PRO-LIFE**

ADVOCATES MUST BE RELENTLESS IN CONTACTING REPRESENTATIVES because reportedly about 300 Planned Parenthood and Family Planning Advocates were in Albany meeting with legislators in early January, looking to maintain (or at least minimize cuts to) funding for their organizations. On 4/21, Reproductive Rights Lobby Day, pro-abortion advocates renewed their call for passage of the Reproductive Health Act S.5808 which would keep abortion legal and remove virtually all restrictions, even if Roe v. Presumed Consent Organ Donation Legislation



On April 27, 2010, *Newsday* reported that NYS Assemblyman Richard Brodsky announced a proposal to make New York State the first in the nation "to pass laws that would presume people want to donate their organs unless they specifically say otherwise." According to Brodsky, 24 European nations have presumed consent laws in place. *Newsday* stated "distracted families would no longer be able to override their loved ones' decisions to donate upon their death. And eventually, hospitals would be able to assume the deceased consented to have his or her organs harvested, unless the person refused in writing." (*Newsday*, April 27, 2010, NY Lawmaker Wants Presumed Organ Donation Consent, AP, Michael Gormley). Brodsky stated, "People's survival should not rest on acts of God alone." The article stated that "106,000 people are on a waiting list that averages 3-4 years for each type of organ." According to the NYS Department of Motor Vehicles, 95% of the 2 million donors on the NYS registry come from driver's licenses. Gormley explained that "the shortage occurs because the need is constant and many donors sign up when they are young, meaning any organ harvest can be years away."

According to the *Newsday* article, Delaware introduced a bill in 2008 that never got out of committee. Critics felt the bill was an intrusion and "treated organs as commodities." New York's presumed consent would come in stages. The primary bill, which according to *Newsday* has strong support, would end what Brodsky said is a common practice by upset relatives who override the checkoffs of driver's licenses and other documents by deceased donors. This would enable hospitals to more quickly prepare a body for organ removal. The next step is far more controversial. In a separate bill, drivers would check a box saying they don't want to donate organs. If the box is not checked, it is presumed the driver wants to donate." Gormley referred to Arthur Kaplan, director of the Center for Bioethics at the University of Pennsylvania. Kaplan noted that all the advances in medicine have resulted in increased demand for organs, while the supply remains static. Kaplan acknowledged, however, that convincing the public to permit harvesting everyone's organs will be quite difficult.

Barbara Pierscionek, Department of Biomedical Sciences, University of Ulster, commented, "The presumption of consent to organ donation cannot be understood in the same way as presumption when applied to science or law. Consideration should be given to the consequences of presuming consent and to the questions of ownership and organ monetary value as these questions are likely to arise should presumed consent be permitted. In addition, the implications of presumed consent on children and adults who are unable to object to organ donation, requires serious contemplation if these most vulnerable members of society are to be protected...Presuming consent for organ donation places the value of body organ function above the requirement for permission from the donor and raises a number of related ethical and legal questions about ownership and sale of body organs, rights of refusal for children and mentally incompetent adults. Measures for the protection of the most vulnerable need to be addressed before legislation to allow for presumed consent can be permitted." (What is presumed when

Wesley J Smith commented on a Letter to the Editor in the journal *Transplantation* (21 (2008) 915) that reported on the physician-assisted death and subsequent organ donation of a Belgian woman. After expressing a desire to donate her organs, an intravenous euthanasia procedure was performed. After 10 minutes without cardiac activity, the woman's liver and kidneys were harvested and transplanted. Smith warns of the "very real prospect that despairing people with terminal illnesses or disabilities (or perhaps, just despair) could latch onto being killed for their organs as a way of bringing meaning to their lives. This is very dangerous territory, made all the more treacherous by doctors, spouses, and a respected medical journal validating the ideas that dead is better than disabled and that living patients can, essentially, be viewed as a natural resource to be killed and mined." The authors of the letter stated, "This case of two separate requests, first euthanasia and second, organ donation after death, demonstrates that organ harvesting after euthanasia may be considered and accepted from ethical, legal and practical viewpoints in countries where euthanasia is legally accepted. This possibility may increase the number of transplantable organs and may also provide some comfort to the donor and his (her) family, considering that the termination of the patient's life may somehow help other human beings in need for organ transplantation." Smith responds, "Taking the organs was the easy decision. Once you've pulled medicine into the forbidden zone of active killing, finding self-congratulatory justifications becomes a most desirable quest...given the number of non voluntary euthanasia deaths in the Netherlands, coupled with the push for 'presumed consent' to harvest organs, 'choice' itself could one day become moot." (www.firstthings.com, secondhand smoke, May 8 2010).

On the same day, Smith cited an article in *Bioethics* by Julian Savulescu and Dominic Wilkinson, bioethicists at Oxford which stated, "It is permissible to withdraw life support from a patient with extremely poor prognosis, in the knowledge that this will certainly lead to their death, even if it would be possible to keep them alive for some time. It is permissible to remove their organs after they have died. But why should surgeons have to wait until the patient has died as a result of withdrawal of advanced life support or even simple life prolonging treatment? An alternative would be to anaesthetize the patient and remove organs, including the heart and lungs...If there were a careful and appropriate process for selection, no patient would die who would not otherwise have died. Organs would be more likely to be viable, since they would not have sustained a period of reduced circulation prior to retrieval...Patients could be assured that their organs would be able to help other individuals." Smith reflected, "If you are a bioethicist, the more brutal your ideas, the more denigrating of human exceptionalism you become, the more crassly utilitarian direction in which your advocacy flows, the more prestigious the university that will give you a tenured chair and a big salary, and the more likely you are to get the big grants."

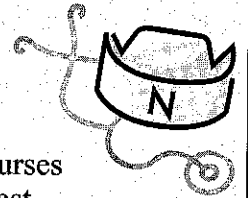

Nassau University Medical Center Nurses Vindicated

Arthur Gianelli, president and CEO of NuHealth System, which operates the Nassau University Medical Center (NUMC), has rescinded sanctions and offered apologies to nurses who refused to assist with an abortion at the East Meadow hospital on March 31st. (See May *Life News*, pg. 2). Eight nurses refused to take part in the abortion and some of them had disciplinary actions against them, such as loss of vacation time.



The Long Island Coalition for Life, when it learned of the incident and disciplinary actions, sent a letter to Mr. Gianelli stating our support of the right of all health care workers to refuse to assist in acts that they conscientiously object to. As a result, Mr. Gianelli invited members of the LICL to meet with him and other NUMC officials to discuss the ongoing investigation into this situation. The LICL also offered support to the nurses. The hospital's investigation eventually determined that the nurses were not at fault and upheld their rights to object in this case. According to Mr. Gianelli, the incident stemmed from a mis-communication on the part of the director of perinatal nursing who mistakenly believed that the patient was in a life threatening condition and reported the nurses' refusals to management which started the disciplinary actions. However, the hospital's review of the situation found that it was not an emergency situation, vindicating the nurses. NUMC has admitted it made mistakes and is now fine tuning its policy on conscientious objection.

NYC Case Now In Courts--LifeNews.com April 30th reports another case of conscientious objection unfolding in NYC where a nurse, Cathy Cenzone DeCarlo, claims that on May 24, 2009 at Mt. Sinai Hospital she was coerced, under threat of losing her job and nursing license, to assist in a late term abortion despite her conscientious objection. Her case has been taken up by the Alliance Defense Fund, which has filed lawsuits in federal and state courts on her behalf.

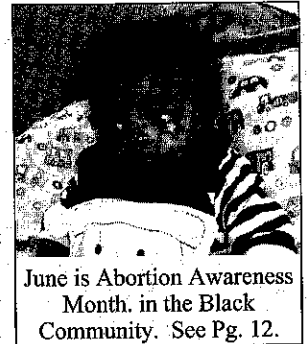

Order of Mercy

John Whitehead, the founder and president of the Rutherford Institute, recently posted an interesting inquiry on the Institute's website: it was titled, and explored the question, "Would you be willing to go to jail for what you believe?"

He seemed to fear too many would answer no, but is perhaps unaware of a fledgling new entity called the Order of Mercy at Gethsemane. Adherents of the order rescued twice last summer in New York, but refused to give their names or recognize the legitimacy of the arrest. Supporters of the order rescued again on December 12 in New York, and twice during Holy Week in Toronto, the latter two at the abortion mill where Linda Gibbons, who wants to become part of the order, has witnessed and been imprisoned regularly since 1994.

Rescue refers to the action when a pro-life person peaceably blocks the entrance to an abortion office with the intent that the mother will be unable to bring her child in to be aborted, thus "rescuing" unborn babies from death.

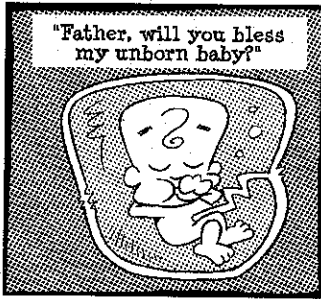
