## FEDERAL LEGISLATION

"...the pro-life cause did not lose tonight, Mitt Romney did" wrote Marjorie Dannenfelser, Pres. of the Susan B. Anthony List, on 11/6. Pro-Lifers saw this election as a critical "fork in the road," and ramped up efforts to register and inform voters. Yet Obama and Romney received *less votes each* than in the Obama vs. McCain election of 2008. Pro-life GOP Senate candidates Akin & Mourdock lost, but a larger number of "moderate to liberal" GOP Senate candidates also lost. Pundits offered a variety of reasons for the loses - changing demographics, more dependent or less virtuous voters, fraud, poor campaigning, candidates too far right, or not far enough. And, too much, or too little, talk about "the Life & Family issues." Fox News exit polling showed 53% blame Bush for the bad economy, 38% blame Obama. By 49%-44%, voters dislike all or most of ObamaCare. In a bright spot, Massachusetts voters rejected euthanasia.

**ObamaCare will bring these changes in 2013:** A yearly cap of \$2,500 into FSA accounts (used to save money for medical or homecare expenses). A 2.3% tax on medical devices. Cuts to hospitals treating low-income seniors.

**Court Cases against ObamaCare** (as of 12/1/2012):  
1) Liberty U's suit was reinstated. It says all employers can't be mandated to give employees insurance, and it violates the Religious Freedom Restoration Act.  
2) ObamaCare says States will set up "Insurance Exchanges"; if they don't, the Federal Govt. will do it by 10/1/13. Oklahoma AG Scott Pruitt's case claims the IRS cannot tax businesses in OK. to fund something the Federal Govt. set up. House GOP members say they'll look into stopping ObamaCare funds via this method, during the lame-duck session.

**HHS mandate** - Hobby Lobby has appealed it's 11/20 lose vs. the HHS mandate. Lawyers for the store say the Administration claims, "...once someone starts a 'secular' business, he categorically loses any right to run that business in accordance with his conscience." But O'Brien Industries has won a temporary hold against the HHS mandate, as has Tyndale Publishing. On 12/6 a federal judge ruled the Archdiocese of NY's lawsuit against the HHS mandate may proceed.

**Sen. Rand Paul** urges the *Life at Conception Act* be reintroduced. (Previously HR.374/S.91) Paul says by defining personhood as beginning at conception, the 14<sup>th</sup> Amendment would then trump, and so end, *Roe v Wade*.

**On 12/4/12, the US Senate defeated the UN Convention on the Rights of Persons with Disabilities (CRPD) Treaty.** Its Article 25 could have been used to force U.S. taxpayers to fund abortions and sterilizations for the disabled in this country.

**ACTION ITEM:** "There is a Civil War brewing in the GOP," said Jennifer Mason, of Personhood USA. The Life Issues are a major part of that war. The LICL urges you to go to the March for Life on 1/25/13, and lobby your Representatives & Senators. Try to bring several people to the Offices with you, who will hopefully carry on the task in the future.



## NEW YORK STATE LEGISLATION

LICL will print information on 2013 legislation as bills are introduced. Bills not voted on in the 2011/2012 session must be re-introduced. Please be alert to oppose an expected new version of the horrific "*Reproductive Health Act*." LICL supports legislation to end abortion funding, supports parental consent, opposes sex-selection abortion, and research using embryonic stem cells.

## HEALTH & SCIENCE

### U.S. Abortion Rate Fell 5% in 2009 According to a New CDC Study

Ben Johnson reported on *LifeSiteNews.com* on 11/21/12 that The Centers for Disease Control (CDC) released a study in November stating that there were 784,507 recorded abortions in 43 states in 2009 - a decrease of 5% from the previous year. Johnson points out, however, that these numbers do not include abortions caused by "emergency contraception" or other abortifacients such as IUDs - the CDC report actually "singles out IUD and hormonal contraception use as part of the reason for the lower rate of abortions performed in facilities, and specifically promotes the increased use of the IUD." He noted that the Associated Press said the report shows "the biggest one-year decrease [in abortion] in at least a decade." Johnson also commented that usually the number of abortions would rise in an economic downturn.

Johnson notes, "The CDC report does not include data from the nation's largest state, California, which also has the largest number of abortion providers. Delaware, Florida, Illinois, Maryland, New Hampshire, Vermont, Wisconsin, and Wyoming also failed to report abortion rates in their respective states...The report reveals that 12 women's deaths are directly attributable to abortion in 2009. Of women who chose an abortion that year, nearly half, 44.7%, had at least one previous abortion; 8.1% had undergone 3 or more abortions. Teenagers accounted for approximately 16% of all abortions. Women aged 20-24 were most likely to procure an abortion. Unmarried women accounted for 85% of all abortions that year, and more than 90% of abortions took place in the first trimester...White women accounted for 37.7% of abortions, black women 35.4%, Hispanics 20.6%...white women had the lowest abortion rates relative to population, while the black abortion rate was nearly 4 times as high."

Randy O'Bannon, Ph.D, from the National Right to Life Committee stated, "When abortions drop, for whatever reason, that's a big deal. Precious unborn lives have been saved and their mothers saved from making a terrible mistake. But figuring out why they may have dropped, even when the exact cause may be unclear, is important too, especially if, like us, you very much want this trend to continue...Significantly, this latest report showed abortions declining by 41,057 over the previous year, a one-year drop of nearly 5%, the largest drop recorded by the CDC in more than 10 years. Moreover the report documents abortion rates and abortion ratios not seen since the Supreme Court legalized abortion in 1973. The CDC says that 'multiple factors are known to influence the incidence of abortion' and goes on to list several: the supply of abortionists, pro-life laws such as waiting periods, parental involvement, increased acceptance of non-marital

childbearing, population shifts, the economy, and factors such as contraception impacting fertility...[the numbers of abortionists], overall, have been fairly stable since 2000, when there were 1,819 abortionists. A steady stream of abortionists has continued to leave the practice, but others, particularly with the advent of chemical abortifacients like RU-486, have picked up the deadly mantle...Population can factor into abortion declines or increases...but sudden shifts are unlikely here. Changing demographics play a role in the long term, but absent some massive special ethnic outreach, will not realistically account for the bulk of drop seen in just a year's time. That abortion rates and ratios have also gone down, reducing the frequency of abortion among pregnant women and among reproductive aged women as a whole is an indication that more than just population shifts are going on...There was, however, a large drop in the U.S. total fertility rate from 2008 to 2009, from what would have been an expected 2.072 children born per woman over her lifetime in 2008 to 2.002 in 2009. This does not appear to stem from a sudden increase in contraceptive use, but it does indicate that the lower abortion rate may have been partly due to fewer pregnancies. The CDC report does not consider the impact of the abstinence movement, but this could, in theory, account for some of this data...Unemployment soared in 2009...Some have tried to claim that tough economic times drive many women to abortion, but these figures appear to show the opposite."

O'Bannon notes that "If Obamacare increases funding to abortion giant Planned Parenthood, one can expect these figures to skyrocket." He acknowledges that ultrasound viewing laws in a number of states may have affected these totals, as well as years of pro-life education and legislation in addition to pro-life organizations, churches and pregnancy care centers. "These numbers also indicate the truth that medical science expresses through ultrasounds, fetal development websites, internet videos is catching up with the discredited lies of the abortion industry, paying off in tangible dividends. We do not yet know whether this same decline will be reflected in national totals published in the future by the Guttmacher Institute, which surveys abortion clinics directly, rather than relying on state reports, as does the CDC. And we will not know for some time whether this trend will continue. But we do know that, thanks in part to your efforts, there are children alive today that would have otherwise perished. These declining numbers represent lives saved. There's a long way yet to go, but it appears we're moving in the right direction." 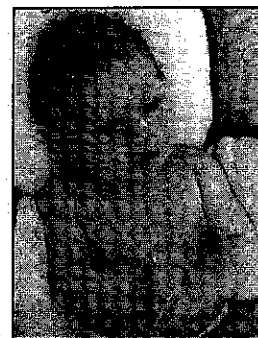
