## CONTINUE TO OPPOSE THE REPRODUCTIVE HEALTH ACT (RHA) with Prayer, Vigilance, and the Action Items Listed.

As of 3/11/13:

- The 2013 Reproductive Health Act S.438 has been introduced by Senator Andrea Stewart-Cousins.
- In his State-of-the-State Speech, 1/9/2013, Gov. Cuomo announced the Reproductive Health Act is part of his proposed 10-point "Women's Equality Act."
- Gov. Cuomo may introduce a different version of RHA.

Pro-Life organizations were quick to respond and coordinate efforts. The RHA is one of the greatest threats to the sanctity of life that New York's pro-life community has ever seen. The bill does not just jeopardize unborn babies' lives; it also jeopardizes the lives and health of pregnant women and girls.

Whether it is a stand-alone bill or part of a larger piece of legislation, the objective is the same. It would proclaim abortion as a fundamental right and impose an extreme abortion agenda on all New Yorkers.

It is a radical bill that would allow non-physicians to perform abortions, permit more late-term abortions, and could be used to compel all medical facilities, including religious hospitals, to allow abortions.

If enacted this bill would, among other things, ensure that abortions are legal throughout all nine months of pregnancy, allow post-viability abortions to be performed on an out-patient basis in clinics, ... could eliminate conscience protection of religious hospitals that refuse to perform abortions.

## FEDERAL LEGISLATION

### Current Pro-Life Bills....

- The *SAFE Act (Stop Abortion Funding in Multi-state Exchange Plans)* HR.346, and it's Senate companion, the *PROTECT Act*, S.154. These bills say the 'Insurance Exchanges' that

ObamaCare creates may not offer multi-State plans that cover abortions (except for rape, incest and life of the mother). It would over-ride State laws.

- The *ObamaCare Repeal Act*, HR.132, and Senate companion S.177, & similar bill HR.45. All would repeal ObamaCare, along with the Healthcare parts of the Reconciliation Act of 2010, and restore prior health laws. (NOTE: LICL opposes the anti-life parts of ObamaCare).

- The *Protecting Seniors' Access to Medicare Act of 2013*, HR.351 & S.351, would cut the *Independent Payment Advisory Board* ('death panel') from ObamaCare. Similar Bill HR.37 would not ban all employer-provided health plans. HR.37 says that no employer or individual is required to provide or have a health insurance policy, and, it bans the Independent Payment Advisory Board.

- HR.61, HR.217 & S.135, known as the *Title X Abortion Provider Prohibition Act*. Would prevent HHS from using any Federal family planning funds to pay for abortions, either directly or via a third party provider, (except for rape, incest, and life of the mother).

- The *Prenatal Nondiscrimination Act (PRENDA)* of 2013, HR.477 & S.138. Outlaws abortions based on the "sex, gender, color or race" of the unborn child. (Exception for a dead unborn child or ectopic pregnancy).

- The *Child Interstate Abortion Notification Act (CIANA)*, HR.732 & S.369. [P. King is a cosponsor of HR.732] Prohibits transporting a minor across State lines to circumvent Parental Notification Laws. There's also the similar, *Child Custody Protection Act of 2013*, S.32.

- The *Homeland Security Respect for Life Act*, HR. 493 Prohibits Dept. of Homeland Security from paying for the abortions of "detainees" (except for rape, incest and life of the mother). Includes conscience protection for DHS employees to protect them from performing abortions.

- The *Health Care Conscience Rights Act*, HR.940, says the HHS Mandate can't force persons or groups to cover drugs or services that violate their conscience. Bans government revenge on health insurers or providers who refuse to do abortions, and lets revenge victims seek relief in Court.

**Note:** As of March 9, the *Life at Conception Act* has not yet been re-introduced. [see: National Pro-Life Alliance]

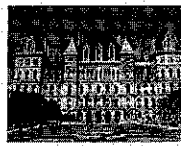

## NEW YORK STATE LEGISLATION

### SUPPORT:

--**Sex Selection Abortion Ban S.2286(Ball)/A.2533 (Crespo)**-to prohibit sex selection abortion.

--**Parental Notification S.1684(Zeldin) and A.3040 (Reilich)**-to place notification requirements on abortions performed on minors.

--**Unborn Victims of Violence S.1950(Ritchie)/A.3128 (Cusick)**-provides that an unborn child at any stage of gestation may be the victim of an assault. This law would have no effect on the practice of legal abortion.

### OPPOSE:

--**Reproductive Health Act S.438 (Stewart-Cousins).**

**IMMEDIATE ACTION - Sample Message to Senators:** Strongly oppose the Reproductive Health Act S.438, an Abortion Expansion Act or any other legislation designed to expand abortion and eliminate conscience rights in NYS. See Page 1.

**Editor's Note: Why Be Alert?** NYS's gun-control law was brought to a vote in January shortly after it was printed. Gov. Cuomo waived the normal three-day waiting period between printing and allowing a vote on the bill. Cuomo used a "message of necessity," which allows an immediate vote - and thus little public debate.

-- **Emergency Contraception Bill S.1494(Krueger)/A.420(Paulin)** "aka **The Unintended Pregnancy Prevention Act**" -Liberalization of emergency contraception distribution, including making emergency contraception available to persons under the age of 17 without a doctor's prescription or parental consent.

--**Conscience Rights of Pharmacists S.3146(Krueger)** -strips conscience protection from pharmacists who object to dispensing of certain medications, such as emergency contraception.

**ACTION:** Ask members to support and co-sponsor, or to oppose accordingly. A separate letter must be sent for each piece of legislation.

### Springtime - Fundraising Season



As the weather gets warmer, many organizations will hold fundraisers including walkathons, 5K runs and other events. Those of us in the prolife movement are often asked by family members and friends to donate or sponsor individuals for these events. We are often asked whether these organizations are pro-life. Before writing out a check or signing up to walk, we should all do our homework and research what type of research the organization supports and what their positions are on issues of concern to us.

American Life League (ALL) researched organizations to determine their positions on "fetal tissue, cell or organ use when that tissue is acquired from direct abortion done at any time during nine months of pregnancy, human embryo research and/or experimentation, human embryonic stem cell research and/or experimentation and human cloning." The list was last updated 2/18/13. You can search alphabetically to see what ALL has to say about most of the major organizations in the US. To see this list, go to [www.all.org](http://www.all.org) and under the Resources tab click Charities.

Sound Choice Pharmaceuticals (SCPI) was "founded to promote consumer awareness about the widespread use of electively aborted fetal material in drug discovery, development and commercialization." SCPI is not afraid to address issues that are polarizing and silencing our nation: the safety of vaccinations, the true promise of stem cell research and the rights of every consumer to know what is in their products. SCPI reviews, researches, and disseminates the context and content of vaccines and other biologic medicines to enable physicians, pharmacists, parents and grandparents to be 'informed consumers' SCPI investigates the biologic and physiologic consequences of human DNA and cellular contaminants in our medicines...SCPI is a nonprofit, biomedical research organization whose cutting edge work has established the connections between genomic instability, retroviral and human fetal contaminants in vaccines, and the worldwide autism epidemic. "The Breast Cancer Prevention Institute (BCPI) was co-founded in 1999 by Drs. Joel Brind, Angela Lanfranchi, John T. Bruchalski and William I. Toffler. Dr. Brind, a scientist and researcher, was aware of risk reduction strategies not widely known to the public and healthcare professionals. Dr. Lanfranchi, a breast cancer surgeon, saw the incidence of breast cancer increasing in young women. She wanted to see this trend reversed. Dr. Bruchalski, an OBGYN and Dr. Toffler, a Family Practice Physician and Professor of Family Medicine saw the need for their patients to know about the abortion/breast cancer (ABC) link and were alarmed at the lack of information available...BCPI educates healthcare professionals and the general public through research publications, lectures and the internet, on ways to reduce breast cancer incidence." 
